**FIRST AMENDMENT TO THE
AGREEMENT BETWEEN
THE CITY OF DORAL
AND
INSITE STREET MEDIA, INC.**

This First Amendment to the Agreement between the **CITY OF DORAL** (“City”) and **INSITE STREET MEDIA, INC** (“Contractor”) executed this 27 day of September, 2023, is made a part of the original Agreement between the parties dated October 30, 2020 (the “Agreement”), between the City and Contractor attached hereto as Exhibit “A”. The City and Contractor hereby agree as follows:

RECITALS

WHEREAS, on October 14, 2020, pursuant to Resolution No. 20-228, the City Council waived competitive bidding, and approved the Agreement between the City and the Contractor for a period of two (2) years, with the option to renew for an additional one (1) year term; and

WHEREAS, the Agreement became effective on October 30, 2020, and is scheduled to expire on October 29, 2023, with no renewal terms remaining; and

WHEREAS, the City is satisfied with the Services provided by the Contractor, and is in need of an additional six (6) month extension of the Agreement, therefore, the City and Contractor now wish to amend the original agreement through this First Amendment to provide for an additional six (6) month renewal term.

NOW THEREFORE, in consideration of the promises and the mutual covenants herein, the parties agree as follows:

1. **EFFECTIVE DATE.** The effective date of this First Amendment shall be October 29, 2023.
2. **AMENDING TERM.** Section 2 “TERM,” is hereby deleted in its entirety, and substituted with the following language:

The initial term of this Agreement shall be for a two (2) year period, with one (1) option to renew.

CITY shall have the sole option to renew this Agreement for the aforementioned one (1) year renewal term. Thereafter, the parties may, by mutual written agreement, opt to renew the Agreement for an additional 6 (six) month term.

3. **EXTENSION OF TERM.** The parties hereby agree to renew the Agreement for a six (6) month term as of the Effective Date of this First Amendment, thereby exercising its last of any renewal options.

4. **OTHER PROVISIONS REMAIN IN EFFECT.** Except as specifically modified herein, all terms and conditions of the original Agreement between the parties shall remain in full force and effect.

5. **CONFLICTING PROVISIONS.** The terms, statements, requirements, and provisions contained in this First Amendment shall prevail and be given superior effect and priority over any conflicting or inconsistent term, statement, requirement or provision contained in any other document or attachment, including but not limited to Exhibit "A".



EXHIBIT "A"

RESOLUTION No. 23-159

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A FIRST AMENDMENT TO THE AGREEMENT WITH INSITE STREET MEDIA TO PROVIDE FOR A SIX (6) MONTH EXTENSION; AUTHORIZING THE CITY MANAGER EXECUTE THE FIRST AMENDMENT TO THE AGREEMENT AND EXERCISE THE ONE-TIME OPTIONAL SIX-MONTH EXTENSION, FOR THE DESIGN, CONSTRUCTION, INSTALLATION, AND MAINTENANCE OF THE CITY'S BUS BENCHES; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on September 22, 2009, the City of Doral ("City") entered into a five (5) year contract with Martin Outdoor Media for the design, construction, installation, and maintenance of the City's bus benches ("Services"); and

WHEREAS, on October 20, 2014, the City exercised a five (5) year renewal option with Martin Outdoor Media, which term expired on October 31, 2019; and

WHEREAS, on September 11, 2019, the City Council approved an extension to the contract with Martin Outdoor Media, which was now operating as InSite Street Media, on a month-to-month basis for a term not to exceed one (1) year; and

WHEREAS, on October 14, 2020, pursuant to Resolution No. 20-228, the City Council waived competitive bidding, and approved a new agreement with InSite Street Media for an initial term of two (2) years, with a one (1) year option to renew, which is set to expire October 29, 2023; and

WHEREAS, the Public Works Department respectfully recommends that the City Council approve a First Amendment to the Agreement with InSite Street Media to provide for a six (6) month extension, and authorize the City Manager to exercise said renewal term.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The First Amendment to the Agreement between the City of Doral and Insite Street Media Inc, attached hereto as Exhibit "A", is hereby approved.

Section 3. Authorization. The City Manager is authorized to execute the First Amendment to the Agreement between the City of Doral and Insite Street Media Inc, attached hereto as Exhibit "A", and to exercise said renewal term under the same terms and conditions of the current contract with InSite Street Media.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Vice Mayor Pineyro who moved its adoption. The motion was seconded by Councilmember Puig-Corve and upon being put to a vote, the vote was as follows:
