Subject: **Adopt-a-Street Application – My 305 Attorneys, P.A.**

Introduction

As part of the City of Doral “Keep Doral Beautiful” campaign, the Public Works Department (PWD) established the “Adopt-a-Street” program in 2005. It provides the opportunity for volunteer groups to clean and remove litter from the City’s public right-of-way at least four (4) times a year for a period of two (2) years. The Program provides the option to automatically renew the agreement if the applicant adheres to the Program requirements. The total weight amount of garbage collected by the volunteers is reported on a yearly basis to the Florida Department of Environmental Protection (FDEP) as part of the National Pollutant Discharge Elimination System (NPDES) permit. My 305 Attorneys, P.A. has applied to take part in this program and continue to help maintain the City streets and Keep Doral Beautiful.

Background

My 305 Attorneys, P.A. firm open their doors in Doral in 2022. They became aware of the program from similar colleagues and want to join the program to make an impact. “By keeping our right-of-way clean and beautiful, we improve the aesthetics of the City and reduce pollution” expressed Mr. Hugo L. Garcia, Esq. My 305 Attorneys, P.A. have applied to adopt NW 79th Avenue from NW 36th Street to NW 58th Street.

Fiscal Impact:

The fiscal impact associated with the program is less than \$50,000, no further analysis is required.

This initiative is aligned with the Exceptional Service Strategic Goal, as it provides the opportunity to build a strong sense of community.

Recommendation
