Subject: Adopt-a-Street Application – Florida General Counsel, P.A.

<u>Introduction</u>

As part of the City of Doral "Keep Doral Beautiful" campaign, the Public Works Department (PWD) established the "Adopt-a-Street" program in 2005. It provides the opportunity for volunteer groups to clean and remove litter from the City's public right-of-way at least four (4) times a year for a period of two (2) years. The Program provides the option to automatically renew the agreement if the applicant adheres to the Program requirements. The total weight amount of garbage collected by the volunteers is reported on a yearly basis to the Florida Department of Environmental Protection (FDEP) as part of the National Pollutant Discharge Elimination System (NPDES) permit. Florida General Counsel, P. A. (FGC) has re-applied to take part in this program and continue to help maintain the City streets and Keep Doral Beautiful.

Background

In 2021, the Mayor and City Councilmembers adopted Resolution No. 21-95 (approved 5-0) approving the adoption of NW 82nd Avenue between NW 12th Street and NW 25th Street by the FGC. During that period, FGC conducted the required cleanup activities as part of their commitment to their adopted street. FGC was a very active participant of the program and removed over 500 pounds of garbage from the City's right-of-way. They also participated in the 2022 and 2023 Earth Day Citywide Cleanup events. FGC's contract adoption of NW 82nd Avenue expired in April 2023. At this time, FGC would like to apply for the adoption of NW 84th Avenue from NW 12th Street to NW 25th Street. FGC is a team of lawyers, general contractors,

architects, engineers, real estate professionals, and insurance professionals who have collaborated to provide FGC's clients with quality legal representation throughout Florida.

Fiscal Impact:

The fiscal impact associated with the program is less than \$50,000, no further analysis is required.

This initiative is aligned with the Exceptional Service Strategic Goal, as it provides the opportunity to build a strong sense of community.

Recommendation

The City's Staff respectfully requests that the Mayor and City Councilmembers approve the application from FGC for the adoption of NW 84th Avenue from NW 12th Street to NW 25th Street. Attached please find the application / agreement form and the applicant's letter of intent.
