Vehicle was unable to stop on time causing the front bumper and hood to collide with pedestrian. Pedestrian had injuries in the right arm and leg. No citation issued.
5/26/2023	18:18	230526-010110	NW 87TH AVE/NW 25TH ST	Adult	Driver of vehicle did not see the pedestrian on the scooter crossing the sidewalk, at which time vehicle's front bumper collided with the pedestrian's right side. Pedestrian was transported by fire rescue. Driver of vehicle was cited .

3/15/2024	10:10	240315-005026	NW 33RD ST/NW 87TH AVE	Adult	A telephone cable wire was hanging across NW 87TH AVE, causing the wire to latch onto the front bumper of the vehicle .While the wire was swinging back from the impact, the pedestrian on the motorized scooter did not see the low wire returning and was struck on the right side of his abdomen area near his ribs. Pedestrian was treated by MDFR. No citation issued.
3/21/2024	12:29	240321-005454	NW 107TH AVE/NW 66TH ST	Juveniles	The pedestrians violated a stop sign and drove into traffic .The scooter front wheel collided with the vehicle's passenger side fender and wheel, causing both riders to eject from the scooter. One the pedestrian collided with the windshield of the vehicle. Both pedestrians were airlifted to Kendal Trauma Hospital. Pedestrian was cited.
