

**RESOLUTION No. 23-211**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AN EXTENDED HOURS PERMIT FOR WHY I AM, LLC, LOCATED AT 3450 NW 83 AVENUE, UNIT 224, PURSUANT TO SECTION 74-195(5) OF THE CITY'S LAND DEVELOPMENT CODE; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Chapter 74, Article IV of the City of Doral ("City") Land Development Code (the "City's Code") regulates the sale of alcoholic beverages and the hours of operation for various vendors; and

**WHEREAS**, Section 74-195(3) of the City's Code authorizes entertainment venues to sell alcoholic beverages for consumption on the premises until 2:00 a.m.; and

**WHEREAS**, entertainment venues located in Downtown Mixed Used Zoning District may apply to remain open for business for the purpose of selling alcoholic beverages for consumption on the premises after 2:00 a.m. pursuant to an extended hours permit in accordance with Section 74-195(5) of the City's Code; and

**WHEREAS**, Why I Am, LLC (the "Applicant") operates a restaurant, bar, and an entertainment establishment located at 3450 NW 83 Avenue, Unit 224, which is classified as an "entertainment venue" located with a Downtown Mixed Used Zoning District for purposes of regulating the sale of alcohol beverages under the City's Code; and

**WHEREAS**, the Applicant seeks approval from the Mayor and City Council for an extended hours permit to sell alcohol beverages for consumption on the premises until 3:50 a.m., as more particularly set forth in their application, attached hereto as Exhibit "A"; and

**WHEREAS**, City staff reviewed the permit application pursuant to Section 74-195(5) of the City's Code and recommends that the Mayor and City Council approve the proposed extended hours permit.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

**Section 2. Approval.** The Mayor and City Council hereby approve the extended hours permit for Why I Am, LLC (the "Applicant") to sell alcoholic beverages for consumption on the premises until 3:50 a.m., subject to the following limitations and conditions:

1. The Applicant shall comply with the City of Doral's Code of Ordinances.
2. The Applicant shall post and maintain the permit within the establishment in a place where it may be seen at all times.
3. The Applicant shall install and maintain a security camera to record all entrance and exit points (excluding emergency exits) used by patrons of the establishment. Security camera recordings shall be retained by the establishment for a minimum of 45 days from the date of recording and shall be made available to the city within three (3) business days of a written request.
4. The Applicant shall maintain on and outside the premises at least one (1) off-duty police officer or (1) private security guard during the extended hours of operation and until all patrons have left the premises, to assure the lawful and orderly conduct of patrons as they arrive at the establishment, during the extended hours of operation, and as they depart. Pursuant to the Conclusion Section of the Physical Security Survey prepared by the City of Doral Police Department, the Applicant may be required to hire additional off-duty police officers as deemed necessary.
5. The Applicant shall prevent intrusive exterior lighting on neighboring residential properties emanating from the establishment during the

extended hours of operation.

6. The Applicant shall fully comply with all local, state, and federal laws applicable to establishments selling alcoholic beverages, including City Code provisions.
7. After 3:50 a.m., no alcoholic beverages shall be sold at the establishment, no customers shall be permitted to enter the premises, and all lighted signage on the exterior of the premises shall be turned off. However, any exterior lighting used to illuminate common areas such as walkways, parking lots, sidewalks, or areas of customer ingress and egress may remain lit.
8. No later than 4:00 a.m., the Applicant shall require that all persons, other than employees or agents of the permit holder, leave the establishment. Thereafter the Applicant shall remove or cause to be removed all alcoholic beverages from the area of the premises utilized by customers, patrons, and invitees; all alcoholic beverages shall be stored in original containers or storage containers on a shelf or cabinet; no alcoholic beverages shall be furnished to, consumed by, or possessed by any person within the premises; and the premises shall remain closed for business until the beginning hours of operation.
9. From 4:00 a.m. until no earlier than 8:00 a.m. the same day, the permit holder shall prohibit entry into the establishment by customers or members of the public.
10. That the Applicant adopt the recommendations provided by the City of Doral Police Department in the Conclusion Section of the Physical Security Survey.
11. The extended hours permit shall be valid for one year from the date of issuance. Businesses approaching their renewal date are responsible for submitting a renewal application form approximately 60 to 90 days before their license is set to expire. Prior approval of an extended hours permit does not create or confer any rights to any permittee. Renewal of the extended hours permit is subject to demonstrated compliance with all local, state, and federal laws concerning alcoholic beverages, adoption of an updated safety and security plan reviewed and approved by the City of Doral Police Department pursuant to Section 74-195(5)(c)(3) of the City's Land Development Code, and all applicable city code provisions. The annual renewal of the extended permit may be approved administratively by the City Manager pursuant to Section 74-195(5)(c)(4) of the City's Land Development Code.
12. The Applicant has voluntarily agreed to participate in a pilot program for the first 6-months of the extended hours permit, whereby the Applicant agrees to work with the City to provide data concerning matters of security, noise,

parking, adverse impacts to neighboring properties, and law enforcement calls for service, so that the City can evaluate the impact of the Applicant's extended hours permit. As part of the aforementioned pilot program, the Applicant agrees to meet with City staff at the conclusion of the 6-month pilot program to review the data obtained to date, and discuss additional conditions that may be imposed on the permit to mitigate any adverse impacts of the extended hours permit identified in the pilot program. The Applicant's participation in this pilot program does not waive the City's ability to suspend or revoke the permit, or impose permit conditions upon the permit, pursuant to Sec. 74-195.

13. The Applicant agrees that the extended hours permit shall only be effective from Wednesday through Saturday, except for recognized federal holidays and for special events, provided that the Applicant provide fourteen (14) days advance written notice to the City that it intends to utilize the extended hours permit for said special event. Notwithstanding the foregoing, pursuant to the Applicant's request, the extended hours permit shall be further limited on Wednesdays to no later than 2:00 am. Therefore, on Wednesdays, all conditions set forth herein and Code regulations applicable to the extended hours permit that reference 3:50 am and 4:00 am, shall be adjusted to 1:50am and 2:00am, respectively. For New Year's Eve, December 31, the permitted hours of sale shall be until 4:59am on the following day, January 1st, pursuant to Section 74-195(4) of the City's Land Development Code.

In addition the grounds for permit suspension set forth in Section 74-195(5)(f) of the City Code, failure of the Applicant to comply with the aforementioned conditions may result in suspension of the extended hours permit.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon its adoption.

The foregoing Resolution was offered by Vice Mayor Puig-Corve who moved its adoption. The motion was seconded by Councilmember Cabral and upon being put to a vote, the vote was as follows:

I additionally acknowledge that the Business Tax Receipt expires on September 30th of each year and must be renewed by this date; otherwise, the City of Doral will undertake such actions as is specified in the Code of Ordinances. As such, on October 1st, a 10% penalty will be assessed, an additional 5% on November 1st, 5% on December 1st and 5% on January 1st of the fiscal year.

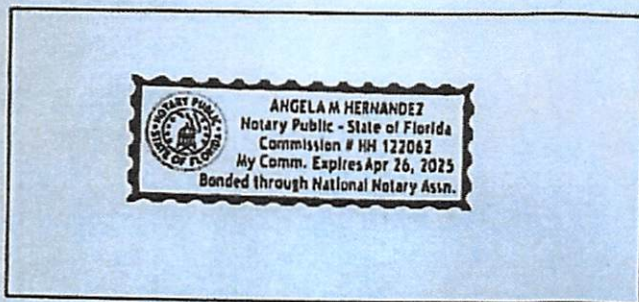
