- (2) Medley acknowledges and accepts the radios in their present condition. ALL RADIOS ARE SOLD AS IS. THE CITY OF DORAL MAKES NO EXPRESS OR IMPLIED WARRANTIES WHATSOEVER INCLUDING, BUT NOT LIMITED TO, THE EXCLUSION OF THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS.
  - (3) Medley agrees that the radios are being sold to Medley in their present condition.
- (4) Medley agrees to unconditionally release, waive, and discharge the City of Doral, its Commission members, employees, agents, and servants, all hereafter referred to as "releasees," from all claims and courses of action, that it, its Commission members, employees, agents and servants may have for any loss, damage, or injury to person or property, whether caused by the negligence, or

otherwise of the releasees.	In addition, Medl	ey agrees to ind	emnify complet	ely, the release	es against
all claims, demands, and ad	ctions arising out	of its actions or	involvement w	ith the use of tl	ne radios.

(5) Doral agrees to relinquish all rights to the radios.
