

**RESOLUTION No. 25-**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT AND USE OF THE CITY LOGO REQUESTED BY EDUARDO OROZCO TO HOST THE “DORAL CHRISTMAS RACE 2025” AS DETAILED IN EXHIBIT A “MAP EVENT SITE” HAVING THE MEETING LOCATION AT DORAL MEADOWS PARK LOCATED AT 11555 NW 58 STREET, DORAL, FL 33166 ON SUNDAY, DECEMBER 21, 2025, FROM 7:30 A.M. TO 9:30 A.M.; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS** Eduardo Orozco (the “Applicant”) seeks approval from the City of Doral to host the “Doral Christmas Race 2025” special event at Doral Meadows Park located at 11555 NW 58 Street, Doral, Florida, 33166, and

**WHEREAS** the purpose of this event is to provide the City of Doral with a community-oriented sport event that elicits participation of runners of different athletic levels and all ages; and

**WHEREAS** staff recommends that the Mayor and City Council approve the proposed “Doral Christmas Race 2025” special event permit to be held on Sunday, December 21, 2025, from 7:30 am to 9:30 a.m., and

**NOW, THEREFORE, BE RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

**Section 2. Approval.** The special event permit for the “Doral Christmas Race 2025” is hereby approved subject to the following conditions:

1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits

upon request from the city.

2. The Applicant shall be required to secure all inspections and approvals prior to the event date.
3. Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number to meet the requirements established by the Building Department.
4. The Applicant is responsible for providing adequate security at the special event. The police department has provided an estimate for crowd control and traffic direction purposes.
5. Miami-Dade Fire Rescue may require the Applicant to provide and pay for fire watch personnel.
6. The Applicant shall comply with the comments made by the City of Doral Police Department and pay all applicable fees no later than 14 days in advance of the event.
7. The applicant should provide adequate parking for the attendees.
8. The Applicant shall comply with the City's noise ordinance.
9. All fees due must be paid within thirty days upon special event approval. All fees must be paid by October 10, 2025. Total fees due for Doral Christmas Race 2025 event are Thirteen Thousand, Five Hundred Seventy Six Dollars and 20/100 (\$13,576.20) which represents Five Thousand, Nine Hundred Thirty Eight Dollars and 18/100 (\$5,938.18) for Police services, Three Hundred Sixty Five Dollars and 00/100 (\$365.00) for Planning and Zoning and Technology fees and Seven Thousand Two Hundred Seventy Three Dollars and 02/100 (\$7,273.02) for Parks rentals and refundable security deposit.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon its adoption.
