## **RESOLUTION No. 25-**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXTEND THE AGREEMENT WITH INSITE STREET MEDIA FOR A SIX (6) MONTH PERIOD WITH A ONE-TIME OPTIONAL SIX-MONTH EXTENSION FOR THE DESIGN, CONSTRUCTION, INSTALLATION. AND MAINTENANCE OF THE CITY'S BUS BENCHES WHILE THE CITY PROCURES A NEW CONTRACT; AUTHORIZING THE CITY **EXTENSION:** MANAGER TO **EXECUTE** THE **AGREEMENT** PROVIDING FOR IMPLEMENTATION; **PROVIDING FOR** INCORPORATION OF RECITALS; AND PROVIDING FOR AN **EFFECTIVE DATE** 

WHEREAS, on September 22, 2009, the City of Doral (the "City") entered into a five (5) year contract, with a one-time optional renewal of five (5) years with Martin Outdoor Media commencing on November 1, 2009, and ending on October 31, 2014, for the design, construction, installation, and maintenance of the City's bus benches; and

WHEREAS, on October 20, 2014, the City executed the optional one-time five (5) year extension of the Bus Bench Contract which expired on October 31, 2019; and

WHEREAS, on September 11, 2019, the Mayor and City Councilmembers approved to extend the current contract agreement with InSite Street Media, formerly known as Martin Outdoor Media on a month-to-month basis with a not to exceed one (1) year period; and

WHEREAS, on October 14, 2020, the Mayor and City Councilmembers approved to enter into a contract agreement with InSite Street Media for a two (2) year period with a one (1) year option to renew for the design, construction, installation, and maintenance of the City's bus bench which is set to expire October 14, 2023; and

WHEREAS, on September 13, 2023, the Mayor and City Councilmembers approved to enter into a contract agreement with InSite Street Media for a six (6) month period for the design, construction, installation and maintenance of the City's bus bench which expired on April 27, 2024; and

WHEREAS, in order to ensure continuity of service while preparing this item for Council approval, the City Manager's Office authorized a limited extension of the contract with InSite Media for a twelve (12) day period until a Second Amendment could be considered for approval at the May 8, 2024, Council Meeting; and

WHEREAS, on May 8, 2023, the Mayor and City Councilmembers approved to enter into a contract agreement with InSite Street Media for a six (6) month period for the design, construction, installation and maintenance of the City's bus bench which is set to expire November 8, 2024; and

WHEREAS, on October 23, 2024, the Mayor and City Councilmembers approved an extension of the current agreement with Insite Street Media for a one-time six (6) month period with a one-time optional six-month extension for the design, construction, installation, and maintenance of the City's bus benches which is set to expire October 1, 2025; and

WHEREAS, the Public Works Department respectfully requests that the Mayor and the City Councilmembers approve the six (6) month contract agreement extension with InSite Street Media, with a one-time optional six (6) month extension, for the design, construction, installation and maintenance of the City's bus benches while Staff

coordinates with Procurement to potentially adopt the Miami-Dade County bus bench contract.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

<u>Section 2.</u> Approval. The six (6) month period with a one-time optional six (6) month contract agreement extension between the City of Doral and In Site Media for a for the design, construction, installation, and maintenance of the City's benches, is hereby approved.

<u>Section 3.</u> <u>Authorization.</u> The City Manager is authorized to extend the contract agreement and execute the contract extension agreement for a six (6) month period with a one-time optional six (6) month extension under the same terms and conditions of the current contract with InSite Street Media.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and City Attorney are hereby authorized to take such action as may be necessary to implement the purpose and the provisions of this resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
