

RESOLUTION No. 26-

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY'S CODE OF ORDINANCES, ADOPTING THE EXISTING CONTRACT WITH GENERAC POWER SYSTEMS, INC. VIA SOURCEWELL CONTRACT No. 020923-GNR FOR THE PURCHASE OF A LIGHT TOWER AS WELL AS ANY OTHER EQUIPMENT, PRODUCTS AND/OR SERVICES AVAILABLE UNDER THE CONTRACT TERMS, WHICH WAS COMPETITIVELY ENTERED INTO IN A MANNER SIMILAR TO THAT SET FORTH IN CHAPTER 2, ARTICLE V, OF THE CITY'S CODE, IN AN AMOUNT NOT TO EXCEED BUDGETED FUNDS; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral Police Department seeks to adopt and utilize the existing contract with Generac Power Systems Inc., via Sourcewell Contract No. 020923-GNR for the purchase of a light tower as well as any other equipment, products, and/or services available under the contract terms mentioned therein and as needed to maintain operational efficiency throughout the City; and

WHEREAS, the light tower is a critical public safety asset that provides high-intensity illumination during nighttime operations, emergency incidents, crime scene investigations, traffic accidents, search-and-rescue missions, and disaster response. This will ensure operational readiness and improve overall emergency response capabilities to the residents of the City of Doral; and

WHEREAS, pursuant to Section 2-322 of the City Code, Staff respectfully requests that the City Council authorize the City Manager to adopt and utilize the existing contract with Generac Power Systems Inc., via Sourcewell Contract No. 020923-GNR for

the purchase of a light tower as well as any other equipment, products, and/or services available from the awarded vendor therein and not to exceed budgeted funds; and

WHEREAS, Staff further requests the City Manager's Office respectfully request authorization from the Mayor and City Councilmembers to utilize the existing contract with Generac Power Systems Inc., via Sourcewell Contract No. 020923-GNR (Exhibit A) and any subsequent renewals, in an amount not to exceed budgeted funds.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. The purchase of the light tower as well as equipment, products, or services available under the contract terms in an amount not to exceed budgeted funds, via the Sourcewell Contract No. 020923-GNR and their subsequent renewals, which was competitively entered into in a manner similar to that set forth in Chapter 2, Article V, of the City Code is hereby approved.

Section 3. Authorization. The City Manager is authorized to utilize the existing contract with Generac Power Systems Inc., via Sourcewell Contract No. 020923-GNR and their subsequent renewals to purchase the light tower as well as equipment, products, and/or services available under the contract terms in an amount not to exceed budgeted funds. This will be funded from the Capital Outlay Account #001.60005.500640 or other most appropriate account(s) as approved in the budget.

Section 4. Implementation. The City Manager and City Attorney are authorized to take any additional actions necessary to implement this Resolution,

including making any modifications, executing any documents and addendums as necessary to effectuate this Resolution, provided that such actions remain consistent with the Council's intent.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.
