

RESOLUTION No. 26-

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, WAIVING THE COMPETITIVE BID PROCESS PURSUANT TO SECTION 2-321 OF THE CITY'S CODE OF ORDINANCES; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH DORAL FENCING CLUB FOR THE PROVISION OF INSTRUCTIONAL FENCING PROGRAMMING AT DORAL LEGACY PARK FOR A PERIOD OF ONE (1) YEAR WITH FOUR (4) ONE (1) YEAR RENEWALS; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral ("City"), through its Parks and Recreation Department, is currently in an agreement with Doral Fencing Club at Doral Legacy Park where they offer instructional fencing programming to our community; and

WHEREAS, through feedback from participants and parents the Parks & Recreation Department determined there is a need to continue this program. They serve between 6 – 15 members monthly, which more than 95% are residents of the City of Doral; and

WHEREAS, Doral Fencing Club entered into a pilot program agreement with the City of Doral on April 9, 2019, to offer Fencing Programming at Doral Legacy Park. This program was highly successful during the pilot program prior to the shutdown from the pandemic and community centers closing; and

WHEREAS, the City went out to bid for recreation programming services in 2021 (RFP #2021-01). Miami Table Tennis was awarded in Res. 21-89 during the April 14, 2021 council meeting; and

WHEREAS, the agreement was signed on June 24, 2021, with a Notice to Proceed signed for July 2, 2021; and

WHEREAS; The agreement was renewed in 2024 and 2025 with an expiration date of July 2, 2026.

WHEREAS, this program is successful with a consistent following and has been well-received by the community.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval & Authorization. The City Council hereby waives the formal bid process pursuant to Section 2-321 of the City's Code Ordinance and authorizes the City Manager to negotiate and enter into an agreement with agreement with Fencing Club for the provision of providing Instructional Fencing Programming. The revenue split will be paid by the provider to the City and deposited into GL account 001.9000.347405 (Recreation-Community Center), subject to the terms and conditions acceptable to the City Manager and City Attorney.

Section 3. Implementation. The City Manager and City Attorney are authorized to take any additional actions necessary to implement this Resolution, including making any modifications, executing any documents and addendums as necessary to effectuate this Resolution, provided that such actions remain consistent with the Council's intent.

Section 4. Effective Date. This resolution shall take effect immediately upon adoption.
