



## **CITY OF DORAL COUNCIL MEETING MEMORANDUM**

### **ITEM TITLE:**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A BID WAIVER PURSUANT TO SECTION 2-321 OF THE CITY'S CODE OF ORDINANCES, AND APPROVING A CONSTRUCTION AGREEMENT WITH METRO EXPRESS, INC. FOR THE PROVISION OF SIDEWALK, CURB & GUTTER, AND MISCELLANEOUS CONCRETE REPAIR CONSTRUCTION SERVICES AT VARIOUS LOCATIONS, AS DETAILED ON THE PROJECT SITE MAP IN AN AMOUNT NOT TO EXCEED FORTY SEVEN THOUSAND SEVEN HUNDRED EIGHTY ONE DOLLARS AND 80/100 (\$47,781.80), WHICH INCLUDES A 10% CONTINGENCY FOR ANY UNFORESEEN CONDITIONS; RECOGNIZING THAT METRO EXPRESS, INC. IS A CITY OF DORAL PRE-QUALIFIED VENDOR; AUTHORIZING THE CITY MANAGER TO EXECUTE THE AGREEMENT AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

### **BRIEF HISTORY:**

On June 14, 2022, the existing contract for "Milling, Resurfacing and Miscellaneous Stormwater and Roadway Improvement" (ITB-2019-12) expired. Consequently, the Public Works Department (PWD) decided not to renew its option of two (2) one (1) year periods in the best interest of the City and its constituents. As a result, the PWD proceeded to fragment the all-encompassing scope of work of the previous contract to its new format of three (3) "scope specific" areas of construction.

On April 21, 2022, The City of Doral ("City") issued Request for Qualification No. 2022-12 "Sidewalk, Curb & Gutter and Miscellaneous Concrete Repair Services". A recommendation was made by the committee to award the top three (3) ranked firms, The American Design Engineering Construction Inc., GPE Engineering & General Contractor Corp., and Miliani Construction Corp., establishing a Pool of Construction Firms for "Sidewalk, Curb & Gutter and Miscellaneous Concrete Repair Services". The Continuing Service Agreements were approved by the Mayor and the City Councilmembers for an initial period of three (3) years with an option of two (2) one (1) year renewals. The American Design Engineering Construction Inc. was removed from the pool as a result of lack of responsiveness and quality of work.

The PWD is in need of a firm to provide Sidewalk, Curb & Gutter and Miscellaneous Concrete Repair Services (the “Work”). As such, the PWD requested a proposal from the two (2) remaining firms on the City’s Pre-Qualified Pool of Construction Firms (GPE Engineering & General Contractor Corp., and Miliani Construction Corp.) for the Work. In addition to the above, Metro Express, Inc., an approved City Registered Vendor, was also invited to provide a proposal for the Work to establish a minimum of three (3) bids.

Metro Express, Inc. provided the lowest proposal in the amount of \$47,781.80, which includes a 10% contingency amount for any unforeseen conditions.
