

**RESOLUTION No. 25-**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING A MUNICIPAL SPONSORSHIP TO PADRES BRILLANTES INC. IN THE AMOUNT OF TWO THOUSAND FIVE HUNDRED DOLLARS AND 00/100 (\$2,500.00), PURSUANT TO SECTION 2-79 OF THE CITY'S CODE OF ORDINANCES; PROVIDING FOR AUTHORIZATION; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Section 2-79 of the Code of Ordinances for the City of Doral ("City") governs municipal sponsorships and provides that each councilmember is allotted \$5,000.00 per fiscal year (contingent upon annual city budget approval) to sponsor eligible applicants whose events, services, and programs support the City's vision, mission, and values as set forth in the City's adopted strategic plan and provide a community benefit; and

**WHEREAS**, the purpose of this section is to establish procedures for all municipal sponsorships, including the disbursement of discretionary funds approved by city councilmembers to sponsor programs, services, events, and charitable and civic organizations that serve a municipal purpose; and

**WHEREAS**, in a continued commitment to supporting non-profit organizations that embody our core values and significantly contribute to the well-being of our community, Mayor Christi Fraga proposes a sponsorship for Padres Brillantes Inc.; and

**WHEREAS**, Padres Brillantes Inc. is a non-profit organization dedicated to motivating, educating, and encouraging parents in the personal and academic development of their children; and

**WHEREAS**, Padres Brillantes Inc. aims to foster good citizens within our communities by engaging with parents through lectures, seminars, events, and counseling, focusing on the vital role of the family in child development; and

**WHEREAS**, the organization operates in various settings, including schools, community associations, other nonprofits, offices, magazines, and media segments, reaching a broad spectrum of parents and guardians; and

**WHEREAS**, recognizing the importance of Padres Brillantes Inc.'s mission and programs, Mayor Christi Fraga proposes a municipal sponsorship of \$2,500.00 (Two Thousand Five Hundred Dollars and 00/100) to support their ongoing initiatives and outreach efforts; and

**WHEREAS**, the City Council finds that the proposed municipal sponsorship complies with Section 2-79 of the City's Code of Ordinances and serves a municipal purpose by strengthening families and promoting community development.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated herein.

**Section 2. Approval & Authorization.** The Mayor and City Council hereby approve the municipal sponsorship proposed by Mayor Christi Fraga to Padres Brillantes Inc. The City Manager is hereby authorized to expend the budgeted funds.

**Section 3. Implementation.** The City Manager is hereby authorized to take such actions as may be necessary to implement this Resolution.

**Section 4. Effective Date.** This Resolution shall take effect immediately upon adoption.
