A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY OF DORAL CODE OF ORDINANCES, AUTHORIZING THE CITY MANAGER TO ACCESS DMS CONTRACT No. 811419 02-VITA- L 8-ACS, AMENDMENT 5, BETWEEN GARTNER, INC. AND STATE BOARD OF ADMINISTRATION OF FLORIDA, FOR THE RENEWAL OF SERVICES WITH GARTNER, INC FOR THE IT LEADERS INDIVIDUAL ACCESS ADVISOR SUBSCRIPTION; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, renewing Gartner services for the IT Leader Individual Access Advisor subscription provides the City of Doral (the "City") with expert, independent guidance to support critical IT decisions; and

WHEREAS, this subscription ensures smarter technology investments, reduces risks, and improves the success of major initiatives by equipping staff with industry-leading research, proven frameworks, and personalized advisory support; and

WHEREAS, with Gartner's resources, the City can evaluate vendors more effectively, negotiate stronger contracts, and adopt innovative solutions that enhance operational efficiency and service delivery for residents; and

WHEREAS, pursuant to Section 2-322 of the City's Code of Ordinances, the City is authorized to purchase supplies, materials, equipment, and contractual services which are the subject of contracts through cooperative purchasing ventures, where the best interest of the City would be served thereby; and

WHEREAS, the City Manager recommends that the City Council approve the renewal of services with Gartner, Inc., for the IT Leaders individual access advisor subscription in an amount not to exceed budgeted funds.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval and Authorization. The renewal of services with Gartner, Inc. for the IT Leaders individual access advisor subscription in an amount not to exceed budgeted funds is hereby approved, and the City Manager is authorized to purchase from Gartner, Inc. utilizing DMS Contract No. 811419 02-VITA- L 8-ACS, amendment 5, between Gartner, Inc. and State Board of Administration of Florida subject to City Attorney approval as to form and legal sufficiency. The City Manager is further authorized to expend budgeted funds as provided for herein. Funding will be provided via the IT Dues/Subscriptions/Memberships account number 001.22005.500540.

<u>Section 3.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution, including, as necessary, negotiating the terms of an agreement in furtherance of the approved purchase.

<u>Section 4.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.
