

**RESOLUTION No. 25-**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, DIRECTING AND AUTHORIZING THE CITY MANAGER'S OFFICE TO WORK WITH VICE MAYOR MAUREEN PORRAS TO EXPLORE PROVIDING AND/OR EXPANDING VOLLEYBALL PROGRAMMING WITHIN THE CITY; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral (the "City") plays a vital role in offering quality sports programming and events that promote active lifestyles, social engagement, inclusion, and well-being for residents of all ages; and

**WHEREAS**, current structured programming includes popular sports such as tennis, soccer, and pickleball, which meet a broad range of community needs; and

**WHEREAS**, volleyball has become an increasingly popular sport among Doral residents, with growing participation both recreationally and competitively through school programs, clubs, and community leagues; and

**WHEREAS**, the City has already recognized outstanding local volleyball talent, including the Ronald Reagan High School Girls Volleyball Team, which was commended for its dedication, sportsmanship, and athletic excellence; and

**WHEREAS**, expanding volleyball programming would provide greater opportunities for youth and residents to develop athletic skills, promote teamwork, and encourage healthy competition; and

**WHEREAS**, this initiative aligns with the City's ongoing commitment to supporting youth athletics, cultivating local talent, fostering leadership development, and enhancing community pride through sports.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and are incorporated herein by this reference.

**Section 2. Support for Expanded Programming.** The City Council hereby expresses its support in moving forward with this resolution to direct and authorize the City Manager's Office to work with Vice Mayor Porras to explore the provision and/or expansion of volleyball programming within the City of Doral. This action aligns with the City's commitment to promoting active lifestyles, youth development, and community engagement.

**Section 3. Implementation.** The City Manager and Parks and Recreation Department are authorized to evaluate and develop expanded volleyball programming, which may include instructional clinics, recreational leagues, competitive programs, and community events, as resources allow.

**Section 4. Effective Date.** This Resolution shall take effect immediately upon adoption.
