

RESOLUTION No. 26-

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE CO-DESIGNATION OF NW 117 AVENUE, FROM NW 34 STREET AND NW 25 STREET AS “FATHER ELKIN SIERRA WAY”; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the “City”), Code, Chapter 38, Article III, provides for the exclusive method for the co-designation of City streets; and

WHEREAS, Father Elkin Sierra, was a devoted priest of the Archdiocese of Miami, who served a great part of his ministry at Our Lady of Guadalupe Church, located in the City; and

WHEREAS, prior to entering the priesthood, Father Sierra dedicated himself to saving lives and protecting the community as a Miami Dade County firefighter, paramedic and public information officer; and

WHEREAS, Father Sierra passed away on April 11, 2023; and

WHEREAS, on May 5, 2026, Miami-Dade County passed Resolution R-409-26, which urges the City of Doral to co-designate N.W. 117th Avenue, from N.W. 34th Street and N.W. 25th Street as “Father Elkin Sierra Way”; and

WHEREAS, the City’s Public Works Department (“PWD”) has evaluated the application and verified that all of the City’s Code requirements has been satisfied; and

WHEREAS, the Public Works Department submits its approval of the N.W. 117th Avenue, from N.W. 34th Street and N.W. 25th Street as “Father Elkin Sierra Way.”

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Incorporation of Recitals. The aforementioned recitals are incorporated herein by reference.

Section 2. Approval. The application for the co-designation of N.W. 117th Avenue, from N.W. 34th Street and N.W. 25th Street as “Father Elkin Sierra Way” is hereby approved.

Section 3. Implementation. The City Manager and City Attorney are authorized to take any additional actions necessary to implement this Resolution, including making any modifications, executing any documents and addendums as necessary to effectuate this Resolution, provided that such actions remain consistent with the Council’s intent.

Section 4. Effective Date. This Resolution shall become effective immediately upon adoption.
