### **BRIEF HISTORY:**

Vice Mayor Digna Cabral has remained committed to supporting organizations that reflect compassion, empathy, and a deep sense of community. Over the past year, several 501(c)(3) nonprofit groups have come to the attention of the Vice Mayor's Office due to the genuine and impactful work they carry out for the most vulnerable among us, whether it be newborns at risk, individuals experiencing homelessness, underprivileged families, or young students striving to become future leaders. These organizations, while distinct in focus, share a common commitment to helping others with dignity and respect. The Vice Mayor's support for them stems from a belief in their missions and the positive effect they have on the lives they touch.
