ITEM TITLE:

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, ADOPTING THE "TITLE VI PROGRAM PLAN" FOR THE CITY OF DORAL TROLLEY SERVICE DATED JUNE 2025; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

DEPARTMENT RECOMMENDATION:

BRIEF HISTORY:

In 2013, the City of Doral, through the Miami-Dade County Department of Transportation and Public Works (DTPW), formerly known as Miami-Dade Transit (MDT), was a sub-recipient of the American Recovery and Reinvestment Act (ARRA) Economic Stimulus Grant funding from the Federal Transit Administration (FTA) for the implementation and construction of ten (10) bus shelters. FTA legislation states that "non-discriminatory use of Federal funds by recipients of FTA assistance, including their sub-recipients and contractors is prohibited". In compliance with the FTA reporting requirements, the Miami-Dade County Department of Transportation and Public Works Office of Civil Rights and Labor Relations (OCR/LR) is responsible for ensuring that each participating municipality complies with Title VI requirements of the 1964 Civil Rights Act. Specifically, the Title VI Act of 1964 states, "No person in the United Stated shall, on the grounds of race, color or national origin, be excluded from, participation in, or be denied the benefits of, or be subject to discrimination under any program or activity receiving Federal financial assistance".

Per FTA requirements, Title VI plans are required to be updated every three (3) years and approved by the local governing body. The Mayor and the City Councilmembers adopted Resolution No. 14-86 (approved 5-0) in May 2014 and Resolution No. 17-220 (approved 3-0, 2 Not Present at Time of Voting) in November 2017, approving the "Title VI Program Plan for the City of Doral Trolley Service. The Mayor and the City Councilmembers adopted the latest Title VI Plan via Resolution No. 22-42 (approved 5-0) on March 9, 2022.

The DTPW Office of Civil Rights and Labor Relations has reached out to the local municipalities to request the latest adopted Title VI plans. The Public Works Department (PWD) revised the previously adopted "Title VI Program Plan for the City of Doral Trolley Service" to account for changes from the previously approved plan (i.e., population increase,

most recent demographics information, increase in service hours and routes, and trolley fleet information).
