

RESOLUTION No. 25-

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE PURCHASES ON BEHALF OF VARIOUS UTILITIES, OTHER MUNICIPAL SERVICES AND PROFESSIONAL MEMBERSHIPS FOR CITY USE AS NEEDED IN FISCAL YEAR 2025-2026; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral ("City") Code of Ordinances ("Code") Section 2-323 sets forth certain exemptions from the City's competitive bidding process subject to City Council approval of any purchases in excess of \$50,000 as set forth in City Code Section 2-318; and

WHEREAS, the City currently utilizes various utilities, services from other government entities, and professional memberships, all of which have been budgeted for Fiscal Year 25-26; and

WHEREAS, services being obtained ranges from electrical, water and sewer, emergency management services (EMS), permitting, and gas; and

WHEREAS, the City hereby wishes to authorize the City Manager to make purchases for various utilities, services from other government entities, and professional memberships for firms and agencies described in Exhibit "A" attached hereto, for Citywide use.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. **Authorization.** The City Council hereby authorizes the City Manager to successfully execute purchases for various utilities, services from other government entities, and professional memberships for Citywide use, as described hereto in Exhibit "A," on an as needed basis, in an amount not to exceed budgeted funds for Fiscal Year 25-26.

Section 3 **Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the provisions of this Resolution.

Section 4. **Effective Date.** This Resolution shall become effective immediately upon adoption.
