

RESOLUTION No. 26-

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE APPLICATION FOR FY26-27 STATE FINANCIAL ASSISTANCE MEMBER PROJECT APPROPRIATIONS THROUGH THE FLORIDA DEPARTMENT OF LAW ENFORCEMENT FOR AWARDED FUNDS IN THE AMOUNT OF SEVEN HUNDRED FIFTY THOUSAND DOLLARS AND 00/100 (\$750,000.00), TO SECURE OVERTIME FUNDING FOR EXPENSES INCURRED BY THE DORAL POLICE DEPARTMENT DURING PRESIDENTIAL AND DIGNITARY-RELATED EVENTS WITHIN THE CITY OF DORAL AND SURROUNDING THE RESORT AREA; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral Police Department has been awarded Seven Hundred Fifty Thousand Dollars and 00/100 (\$750,000.00) from the State Financial Assistance Member Project Appropriations through the Florida Department of Law Enforcement FY26-27 as an award and expend funds in an amount not to exceed Seven Hundred Fifty Thousand Dollars and 00/100 (\$750,000.00), which will be used to secure overtime funding for expenses incurred by the City of Doral's Police Department during President of the United States (POTUS) and dignitary-related events within the City and surrounding the resort area; and

WHEREAS, the funding allows the Department to recover costs associated with providing security support to federal agencies during elevated national-security operations; and

WHEREAS, Staff respectfully requests that the Mayor and City Council authorize the application to the State Financial Assistance Member Project Appropriations through the Florida Department of Law Enforcement FY26-27 for funds in the amount of \$750,000.00 as an award and expend said funds to recover overtime costs associated

with providing security support to federal agencies during elevated national-security operations.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. The City Manager hereby authorizes the application for the State Financial Assistance Member Project Appropriations funding through the Florida Department of Law Enforcement for Fiscal Year 2026–2027 in the amount of Seven Hundred Fifty Thousand Dollars (\$750,000.00). The City Manager is further authorized to accept and expend the awarded funds in an amount not to exceed Seven Hundred Fifty Thousand Dollars and 00/100 (\$750,000.00) from the following accounts: Revenue Account No. (001.6000.334202)-State Grant and Expense Account No. (001.60005.500140)-Overtime to reimburse and recover overtime costs incurred in providing security support to federal agencies during elevated national security operations.

Section 3. Authorization: The City Manager is hereby authorized to receive the awarded funds and expend said funds (reimbursable) on behalf of the City.

Section 4. Implementation. The City Manager and City Attorney are authorized to take any additional actions necessary to implement this Resolution, including making any modifications, executing any documents and addendums as necessary to effectuate this Resolution, provided that such actions remain consistent with the Council's intent.

Section 5. Effective Date. This Resolution shall become effective immediately upon its adoption.
