A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY ANTHONY ALBELO CEO OF LOUD & LIVE INC. TO HOST THE HOUSE OF HORROR CARNIVAL FROM THURSDAY, SEPTEMBER 26, 2024 THROUGH THURSDAY, OCTOBER 31, 2024 VARYING IN TIMES FROM 5:30 PM TO 12:00 AM ACCORDING TO SCHEDULE PROVIDED IN EXHIBIT "A", AT 1625 NW 107 AVE DORAL, 33172; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Anthony Abelo (the "Applicant") seeks approval from the City of Doral

of a special event permit to host the "House of Horror Carnival" (the event) at 1625 NW 107

Avenue, Doral, 33172; and

WHEREAS the purpose of the "House of Horror Carnival" event is to provide the

public with a Halloween themed attraction featuring amusement rides, and haunted houses;

and

WHEREAS, this recurrent event is a South Florida premier Halloween themed

attraction backed by a valued campaign promoting the City of Doral; and

WHEREAS, staff recommends that the Mayor and City Council approve the proposed special event permit to host the "House of Horror Haunted Carnival" from Thursday, September 26, 2024 through Thursday, October 31, 2024 at 1625 NW 107 Ave, Doral, FL 33172.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Approval. The special event permit for the "House of Horror Carnival";

is hereby approved subject to the following conditions:

- 1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.
- 2. The Applicant shall be required to have all inspections and approvals prior to the event date.
- 3. Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number as to meet the requirements established by the Building Department.
- 4. The Applicant is responsible for providing adequate security at the special event. The police department may require the Applicant to provide and pay for security personnel for crowd control and traffic direction purposes.
- 5. The county fire rescue department may require the Applicant to provide and pay for fire watch personnel.
- 6. The Applicant shall comply with comments made by the City of Doral Police Department and pay all applicable fees no later than 14 days in advance of the event.

Section 3. Effective Date. This Resolution shall take effect immediately upon

adoption.
