



## **CITY OF DORAL COUNCIL MEETING MEMORANDUM**

### **ITEM TITLE:**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE SHARED PARKING USE AGREEMENT WITH THE OFFICE OF THE SUPERVISOR OF ELECTIONS FOR MIAMI-DADE COUNTY, FOR THE PURPOSE OF PARKING AT DORAL CENTRAL PARK DURING ELECTIONS AND ELECTION RELATED ACTIVITIES; AUTHORIZING THE CITY MANAGER TO EXECUTE THE SHARED PARKING USE AGREEMENT; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

### **BRIEF HISTORY:**

Pursuant to the Interlocal Agreement executed in December 2004, through which Miami-Dade County ("County") deeded Doral Central Park (formerly Miami West Park) to the City, both the County and the City agreed to make parking available "for the purposes of parking during elections and election-related activities."

In alignment with the obligations set forth in the Interlocal Agreement, the City and the Miami-Dade County Office of the Supervisor of Elections now desire to enter into this Shared Parking Use Agreement to establish the terms and conditions for the continued shared use and maintenance of the designated Parking Area.

In addition to defining the use and maintenance responsibilities associated with the Parking Area, the agreement also provides for a financial contribution from the Office of the Supervisor of Elections. Specifically, the Office of the Supervisor of Elections will contribute the lesser of (1) a lump sum equal to fifty percent (50%) or (2) a lump sum of two hundred thousand dollars (\$200,000.00), toward the paving improvements of the Parking Area. The City will remain responsible for contracting, managing, and overseeing the paving work in accordance with all applicable standards and specifications.
