Introduction

Eduardo Orozco (the "Applicant") is requesting approval of a special event from the Mayor and the City Council to host the Doral Christmas Race 2025, pursuant to Chapter 35 of the City Code of Ordinances ("City Code"). The proposed event will be hosted by Leon Sport within close to traffic area detailed in Exhibit A, event map site area from 7:30 am to 9:30 am on Sunday, December 21, 2025. Meeting location is Doral Meadows Park located at 11555 NW 58 Street, Doral. A copy of the application is provided in "Exhibit A".

Background

The purpose of this special event is to provide the City of Doral with a fun family and community-oriented event that elicits participation of runners of different athletic levels and ages. The City of Doral encourages a lifestyle of fitness, and community participation and the Doral Christmas 5K event will offer the opportunity for participants to enjoy themselves during the holiday season. Moreover, this 5K event will re-affirm the city's initiative and commitment to establish the City of Doral as a sport enthused city while offering residents and visitors a safe environment to enjoy

another holiday gathering in the City of Doral. The event will have DJ provided music, sponsors, and non-alcoholic beverages for the participants and guests.

The applicant estimates an attendance of approximately 1000 participants. Pursuant to Chapter 35 of the City of Doral Code of Ordinances ("City Code"), events anticipating 400 or more attendees require approval by the City Council.
