A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY CASSIE COLLETTI TO HOST THE "PATH TO A CURE" AT DORAL GLADES PARK, LOCATED 7600 NW 98 PLACE, DORAL AS DETAILED IN EXHIBIT A ON SUNDAY, FEBRUARY 8, 2026, FROM 9:00 A.M. TO 2:00 P.M.; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS Cassie Colletti ("Applicant") seeks approval from the City of Doral (the "City") to host the "Path to a Cure" special event at Doral Glades Park as detailed in Exhibit A, and

WHEREAS the purpose of this event is to raise funds for Mission MSA, a not-forprofit foundation dedicated to providing awareness and, research and support to all affected by Multiple System Atrophy (MSA), and

WHEREAS staff recommends that the City's Mayor and Council approve the proposed "Path to a Cure" special event permit to be held on Sunday, February 8, 2026, from 9:00 a.m. to 2:00 p.m.

NOW, THEREFORE, BE RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

Section 2. Approval. The special event permit for the "Path to a Cure" is hereby approved subject to the following conditions:

1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.

- 2. The Applicant shall be required to secure all inspections and approvals prior to the event date.
- The Applicant is responsible for providing adequate security at the special event. The police department has provided an estimate for crowd control and traffic direction purposes.
- 4. Miami-Dade Fire Rescue may require the Applicant to provide and pay for fire watch personnel.
- 5. The Applicant shall comply with the comments made by the City of Doral Police Department and pay all applicable fees no later than 14 days in advance of the event.
- 6. The applicant should provide adequate parking for the attendees.
- 7. The Applicant shall comply with the City's noise ordinance.
- 8. All fees due must be paid within thirty days upon special event approval. All fees must be paid by December 12, 2025. Total fees due for the "Path to a Cure" special event are Three Thousand, Seven Hundred Forty Eight Dollars and 80/100 (\$3,748.80), which represents Four Hundred Eight Dollars and 80/100 (\$408.80) for Police services, and Three Hundred Sixty Five Dollars and 00/100 (\$365.00), for Planning and Zoning and Technology fees and Two Thousand, Nine Hundred Eight Dollars and 80/100 (\$2,908.80) for park rentals and refundable security deposit.

<u>Section 3.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.
