

**RESOLUTION No. 25-**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, EXECUTING AN AGREEMENT WITH REY VALDES FOR THE PROVISION OF INSPECTOR GENERAL SERVICES; PROVIDING FOR INSTRUCTIONS TO THE MAYOR AND THE CITY ATTORNEY; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral (the “City”), voted in its April 2025 meeting to appoint Rey Valdes as the Inspector General for the City; and

**WHEREAS**, pursuant to the City of Doral Code of Ordinances, the Mayor and City Attorney are to negotiate an agreement with Rey Valdes for Inspector General; and

**WHEREAS**, the City Attorney and Mayor have negotiated an agreement with Rey Valdes that is attached hereto as Exhibit “A.”

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The aforementioned “WHEREAS” clauses are hereby incorporated by reference.

**Section 2. Authorization.** The City Mayor and Council hereby authorize the Mayor to execute the enclosed agreement with Mr. Valdes in substantially the same form as enclosed hereto as Exhibit “A.”

**Section 3. Instruction.** The Mayor and Council hereby instruct the Mayor and City Attorney to execute any and all documents necessary to effectuate this resolution

**Section 4. Implementation.** The City Manager and City Attorney shall take all necessary steps to implement this Resolution, and expend budgeted funds.

**Section 5. Effective Date.** This Resolution shall become effective immediately upon adoption.
