Dear Agent,

This was a traffic stop by a Doral PD officer. We write to both MDSO and Doral because we believe that MDSO handles the police dispatch and maybe any 911 calls.

Also, we are asking MDSO and Doral PD for all communications for any 911 calls or county or Doral police communications about this case

I represent the Defendant in this matter. This is a request pursuant to Chapter 119, Florida Statutes and a demand to preserve evidence.
