### **Introduction**

Eduardo Orozco (the “Applicant”) is requesting approval of a special event permit and the use of the City logo from the Mayor and the City Council to host the “Gran Fondo Giro D’ Italia”, pursuant to Chapter 35 of the City Code of Ordinances (“City Code”). The proposed event will be hosted by Leon Sport, and cyclists will depart from City Place located at 8300 NW 36 Street, Doral. The Gran Fondo Giro D’ Italia will take place Saturday, February 7, and Sunday, February 8, 2026, from 7:00 am to 2:00 pm. A copy of the application is provided in “Exhibit A”.

### **Background**

The purpose of this special event is to bring to the City of Doral a premier cycling event that promotes health, wellness and community engagement. Gran Fondo Giro D’Italia will foster community participation, support local businesses and showcase the City of Doral by attracting cycling enthusiasts beyond the City of Doral. This event will offer recorded music, and alcoholic beverages. Participation in this event is estimated to be of one thousand (1,000) participants. *Events that expect 400 or more attendees shall require the approval of the City Council, pursuant to City Code Section 35-20(d).*

Under the City Code, special events in public locations require a permit from the Planning and Zoning Department, with certain larger events also requiring City Council approval. The total estimated attendance is 1,000 participants.

This foundation has previously sponsored similar events, including:

- Run Doral 2025, 1,900 participants
- Doral 5K Christmas Race 2025, 700 participants
- Run Doral 2024, 1,250 participants
