

RESOLUTION No. 26-

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO UTILIZE SOURCEWELL CONTRACT No. 052324-LFF AND ACCEPT THE PROPOSAL FROM LIFE FITNESS, FOR THE PURCHASE OF ADDITIONAL FITNESS EQUIPMENT FOR DORAL CENTRAL PARK FITNESS & COMMUNITY CENTER AND ENHANCEMENTS TO THE CARDIO DECK AT DORAL LEGACY PARK, FOR AN AMOUNT NOT TO EXCEED APPROVED BUDGETED FUNDS; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral ("City") is committed to maintaining high standards in recreational facilities and ensuring safety and enjoyment for its residents and visitors; and

WHEREAS, Doral Central Park Fitness & Community Center continues to experience high utilization of its fitness center, with over 2,000 registered members, creating a need to enhance the space to better accommodate the high volume of members; and

WHEREAS, the City desires to purchase additional fitness equipment from Life Fitness to enhance the weight room, improve circulation within the fitness area, and prioritize member safety by helping ensure sufficient spacing around weight-lifting machinery; and

WHEREAS, the City desires to enhance the cardio deck at Doral Legacy Park; and

WHEREAS, staff respectfully requests the approval from the Mayor and City Councilmembers to authorize the City Manager to accept the proposal submitted by Life Fitness, utilizing Sourcewell contract 052324-LFF for the purchase of additional fitness equipment in an amount not to exceed approved budgeted funds per fiscal year.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The Mayor and City Councilmembers hereby approve the City Manager to accept the proposal submitted by Life Fitness, utilizing Sourcewell contract 052324-LFF for the purchase of additional fitness equipment in an amount not to exceed approved budgeted funds per fiscal year. The agreement is subject to approval by the City Attorney as to form and legal sufficiency and on such other terms and conditions as may be appropriate to protect and further the interest of the City. This authorization does not create or confer any rights to Field Turf or any of the other firms.

Section 3. Authorization. The Mayor and City Councilmembers authorize the City Manager to accept the proposal by Life Fitness, utilizing Sourcewell contract 052324-LFF for the purchase of additional fitness equipment in an amount not to exceed approved budgeted funds per fiscal year.

Section 4. Implementation. The City Manager and City Attorney are authorized to take any additional actions necessary to implement this Resolution, including making any modifications, executing any documents and addendums as necessary to effectuate this Resolution, provided that such actions remain consistent with the Council's intent.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.
