A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING SCHOOL RESOURCE OFFICER AGREEMENTS WITH DORAL ACADEMY ELEMENTARY (JAM); DORAL ACADEMY CHARTER MIDDLE/PREPARATORY SCHOOL; RENAISSANCE ELEMENTARY CHARTER SCHOOL; RENAISSANCE MIDDLE CHARTER SCHOOL; DOWNTOWN DORAL CHARTER ELEMENTARY SCHOOL; DOWNTOWN DORAL CHARTER UPPER SCHOOL; DORAL INTERNATIONAL ACADEMY OF MATH AND SCIENCE; BRIDGEPREP ACADEMY DORAL; SHELTON ACADEMY; DIVINE SAVIOR ACADEMY DORAL; AND ACADEMIR CHARTER SCHOOL EAST TO ASSIST IN THE PREVENTION OF JUVENILE DELINQUENCY AND MITIGATION OF CRITICAL INCIDENTS THROUGH THE PROVISIONS OF THE PROGRAM; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

BRIEF HISTORY:

The City of Doral has established a School Resource Officer (SRO) Program pursuant to applicable Florida law. In order to meet the requirements imposed by the Marjory Stoneman Douglas High School Public Safety (MSDHS) Act and specifically the provisions of Fla. Stat. Section 1006.12, the schools desire that the City of Doral provide a law enforcement officer to serve as it's School Resource Officer.

The City and Schools understand and agree that the SRO Program is established for the assistance in the prevention of juvenile delinquency through the provisions of programs specifically developed to respond to those factors and condition that give rise to delinquency. This upcoming fiscal year 25-26 the Schools shall pay the City the sum of \$91,052.00 under the terms of the agreement, which is to be paid in ten (10) equal payments of \$9,105.20 of each month from September 2025 to June 2026. The agreements are renewed yearly.
