This Bill of Sale is made on the _____ day of _____, 2026 between the Village of Biscayne Park, Florida (herein "Biscayne Park") and the City of Doral, Florida (herein "Doral").

WHEREAS, Doral is a Florida municipal corporation which currently owns the following two (2) Harley Davidson motorcycles:

WHEREAS, Biscayne Park is a Florida municipal corporation which is currently in need of police motorcycles; and

WHEREAS, the Doral Police Department recently acquired 10 new Harley-Davidson motorcycles, creating a surplus of police motorcycles that we are pleased to make available; and

WHEREAS, Biscayne Park Police Department has expressed interest in acquiring two police motorcycles for departmental use, as current funding limitations and varying levels of disrepair have impacted its existing fleet; now, therefore

IN CONSIDERATION of the mutual covenants and conditions herein expressed and the faithful performance of all such covenants and conditions undersigned Doral and Medley do mutually agree as follows:

(1) Biscayne Park agrees to pay Doral one dollar (\$1.00) for the purchase of the above listed police motorcycles from the City of Doral in "as is" condition.

(2) Biscayne Park acknowledges and accepts the police motorcycles in their present condition. ALL POLICE MOTORCYCLES ARE SOLD AS IS. THE CITY OF DORAL MAKES NO EXPRESS OR IMPLIED WARRANTIES WHATSOEVER INCLUDING, BUT NOT LIMITED TO, THE EXCLUSION OF THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS.

(3) Biscayne Park agrees that the police motorcycles are being sold to Biscayne Park in their present condition.

(4) Biscayne Park agrees to unconditionally release, waive, and discharge the City of Doral, its Commission members, employees, agents, and servants, all hereafter referred to as "releasees," from all claims and courses of action, that it, its Commission members, employees, agents and servants may have for any loss, damage, or injury to person or property, whether caused by the negligence, or otherwise of the releasees. In addition, Medley agrees to indemnify completely, the releasees against all claims, demands, and actions arising out of its actions or involvement with the use of the radios.

(5) Doral agrees to relinquish all rights to the police motorcycles.
