ITEM TITLE:

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER, PURSUANT TO SECTION 2-322 OF THE CITY'S CODE OF ORDINANCES, TO UTILIZE THE MASTER AGREEMENT WITH THE HILLSBOROUGH COUNTY SHERIFF'S OFFICE AND ALLIGATOR ALLEY HARLEY DAVIDSON (HCSO SUPPLIER SI-301227), FOR THE PURCHASE OF 10-ROAD KING HARLEY-DAVIDSON MOTORCYCLES TO INCLUDE PRODUCTS AND SERVICES IN AN AMOUNT NOT TO EXCEED BUDGETED FUNDS; AUTHORIZING THE CITY MANAGER TO EXPEND FUNDS FROM ACCOUNT No. 001.60005.500641; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

BRIEF HISTORY:

The Police Department, in accordance with the City of Doral Procurement Ordinance which requires all purchases of or contracts for materials, supplies, equipment, public improvements or services where the total amount to be expended is more than \$50,000.00 to be brought before the City Council for approval prior to execution, requests that the following item be considered:

In line with previous replacement strategy objectives, the City of Doral Police Department recommends the replacement of 10 Harley Davidson motorcycles. These motorcycles have accumulated significant mileage and show signs of extensive wear, making them due for replacement. The Police Department was approved to purchase 10- Harley Davidson motorcycles to replace the ones previously mentioned. The Police Department will purchase said motorcycles from Alligator Alley Harley Davidson via the Hillsborough County Sheriff's Office (HCSO Supplier S1- 301227) in an amount not to exceed budgeted funds.
