

RESOLUTION No. 26-

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A PROPOSED WORK OF PUBLIC ART AT THE COLLECTION SUITES II PROJECT LOCATED AT 5990 NW 102 AVENUE, ON TWO PARCELS OF LAND WITH FOLIO NOS. 35-3017-001-0394 & 35-3017-001-0393, PURSUANT TO CHAPTER 75 OF THE CITY'S LAND DEVELOPMENT CODE; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on June 15, 2015, the City of Doral (the "City") implemented the Public Arts Program to guide the placement of public art in private and public venues in the City; and

WHEREAS, the intent of the City's Public Arts Program is to stimulate the area's cultural environment, heritage, diversity, and create unique community character through public and private artworks integrated into the architecture, infrastructure, and landscape of new developments; and

WHEREAS, Galileax Two, LLC (the "Applicant") has elected the option to install artwork within the Collection Suites II (the "Project") property as specified in Chapter 75, "Public Arts Program" of the City's Land Development Code; and

WHEREAS, the Applicant and Alberto Cavalieri (the "Artist") have identified an artistically designed public art initiative composed of knotted steel bars formed from modular pieces joined by bolts and anchored to a solid concrete base that will embody the principles of law, order, and justice to be installed at the Project located on two parcels at 5990 NW 102nd Avenue, with folio nos. 35-3017-001-0394 and 35-3017-001-0393; and

WHEREAS, on May 12, 2026, the City's Public Arts Program Committee held a meeting, and a concept proposal of public artwork was presented to the City's Public Arts

Program Advisory Board for review; and

WHEREAS, after evaluating the applicant's proposal and considering all testimony, the Public Arts Program Committee voted unanimously (4-0) in favor of approval without conditions; and

WHEREAS, Staff respectfully recommends approval from the Mayor and City Council of the Public Arts Program application submitted by the City of Doral, for the Collection Suites II project.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. The Mayor and City Council hereby approve the Public Arts Program application by Galileax Two, LLC, for the Collection Suites II project located at 5990 NW 102nd Avenue on two parcels with folio nos. 35-3017-001-0394 & 35-3017-001-0393, attached hereto as "Exhibit A."

Section 3. Implementation. The City Manager and City Attorney are authorized to take any additional actions necessary to implement this Resolution, including making any modifications, executing any documents and addendums as necessary to effectuate this Resolution, provided that such actions remain consistent with the Council's intent.

Section 4. Effective Date. This resolution shall take effect immediately upon adoption.
