

RESOLUTION No. 25-

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, DIRECTING THE CITY MANAGER TO CREATE A PUBLICLY ACCESSIBLE ONLINE DASHBOARD TO DISPLAY THE ATTENDANCE RECORDS OF ALL CITY COUNCIL MEMBERS FOR REGULAR MEETINGS, SPECIAL MEETINGS AND WORKSHOPS; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, transparency and accountability are essential to maintaining public trust in government; and

WHEREAS, the City of Doral Charter establishes attendance requirements and rules for council members to ensure consistent participation in City business; and

WHEREAS, residents have an interest in knowing the attendance records of their elected officials to stay informed about their engagement and commitment to City responsibilities; and

WHEREAS, providing a user-friendly dashboard on the City's official website to display attendance data would allow residents to easily view and track the participation of each council member; and

WHEREAS, such a dashboard would include attendance for all regular and special meetings as documented by the City Clerk and would be updated promptly after each meeting; and

WHEREAS, the City Council desires to enhance government transparency by implementing this measure in alignment with the attendance provisions of the City Charter.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Creation of Attendance Dashboard. The Mayor and City Council hereby direct the City Manager to design and launch an online dashboard on the City of Doral's website that displays each Council Member's attendance record for all regular meetings, special meetings, and workshops. The dashboard shall be updated following each meeting by the Office of the City Clerk, reflect attendance in accordance with the requirements outlined in the City Charter, and be easily accessible and understandable by the public.

Section 3. Implementation. The City Manager shall coordinate with the relevant departments and the City Clerk to ensure timely implementation and ongoing maintenance of the dashboard.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.
