

**RESOLUTION No. 26-**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, WAIVING THE COMPETITIVE BID PROCESS AS PER SECTION 2-321 OF THE CITY OF DORAL CODE OF ORDINANCES, AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH 4SOUND GROUP FOR THE PROVISION OF SOUND, LIGHTING, AND LED SCREEN SERVICES FOR THE CITY'S INDEPENDENCE DAY CELEBRATION EVENT ON JULY 4, 2026 AT DORAL CENTRAL PARK, IN AN AMOUNT NOT TO EXCEED SEVENTY EIGHT THOUSAND, ONE HUNDRED NINETY DOLLARS AND 50/100 (\$78,190.50); PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral Parks and Recreation Department is coordinating the City's Independence Day Celebration event scheduled for Saturday, July 4, 2026, at Doral Central Park; and

**WHEREAS**, the City requires professional sound, lighting, and LED screen services to support the successful execution of the event and ensure a safe and high-quality experience for residents and attendees; and

**WHEREAS**, the Parks and Recreation Department solicited quotes from multiple vendors for the provision of sound, lighting, and LED screen services for the event; and

**WHEREAS**, three (3) companies submitted proposals based on the sound projection requirements and event layout provided by the City; and

**WHEREAS**, upon review of the proposals received, staff determined that two of the firms demonstrated comparable capabilities, technical projections, and prior experience providing services at the Doral Central Park Amphitheater; and

**WHEREAS**, after further evaluation, 4Sound Group was determined to provide the best overall value to the City based on the quality of equipment proposed, technical capabilities, prior experience, and competitive pricing; and

**WHEREAS**, funding for these services is available within the Parks and Recreation Department's Contractual Services Account 001.90005.500340, and shall not exceed Seventy Eight Thousand, One Hundred Ninety Dollars and 50/100 (\$78,190.50); and

**WHEREAS**, this item supports the Parks and Recreation Department's large-scale community event initiatives celebrating the nation's Independence Day and America's 250th Anniversary, while promoting community pride, resident engagement, and family-oriented recreational opportunities; and

**WHEREAS**, the Mayor and City Council find it in the best interest of the City to authorize the City Manager to negotiate and enter into an agreement with 4Sound Group for the provision of sound, lighting, and LED screen services for the City's Independence Day Celebration event.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval & Authorization.** The Mayor and City Council hereby waive the competitive bid process as per section 2-321 and approve the City Manager to negotiate and enter into an agreement with 4Sound Group for the provision of sound, lighting, and LED screen services for the City's Independence Day Celebration event scheduled for July 4, 2026, at Doral Central Park, in an amount not to exceed Seventy Eight Thousand, One Hundred Ninety Dollars and 50/100 (\$78,190.50). Funding for this project is allocated in the Contractual Services account 001.90005.500340.

**Section 3. Implementation.** The City Manager and City Attorney are authorized to take any additional actions necessary to implement this Resolution, including making any modifications, executing any documents and addendums as necessary to effectuate this Resolution, provided that such actions remain consistent with the Council's intent.

**Section 4. Effective Date.** This Resolution shall take effect immediately upon adoption.
