

RESOLUTION No. 26-

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE BILL OF SALE WITH THE VILLAGE OF BISCAYNE PARK FOR THE SALE OF TWO HARLEY DAVIDSON MOTORCYCLES; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral is a Florida municipal corporation which currently owns the following two police motorcycles;

WHEREAS, Village of Biscayne Park is a Florida municipal corporation which is currently in need of police motorcycles; and

WHEREAS, the Doral Police Department recently acquired 10 new Harley Davidson motorcycles, which has resulted in a surplus of police motorcycles that we are eager to share; and

WHEREAS, the Village of Biscayne Park has voiced its interest in acquiring the police motorcycles for departmental use;

WHEREAS, the City Council finds that it is in the best interest of the City to donate the aforementioned police motorcycles, which are no longer of use or value to the Doral Police Department, to the Village of Biscayne Park.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. The City Council of the City of Doral hereby approves the Bill of Sale between the City of Doral and the Village of Biscayne Park for the sale of two Harley Davidson motorcycles, which the Bill of Sale is attached hereto and incorporated herein as Exhibit "1".

Section 3. Implementation. The City Manager and City Attorney are authorized to take any additional actions necessary to implement this Resolution, including making any modifications, executing any documents and addendums as necessary to effectuate this Resolution, provided that such actions remain consistent with the Council's intent.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.
