

**RESOLUTION No. 25-**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY'S CODE OF ORDINANCES, AUTHORIZING THE CITY MANAGER TO UTILIZE THE MASTER AGREEMENT WITH THE HILLSBOROUGH COUNTY SHERIFF'S OFFICE AND ALLIGATOR ALLEY HARLEY DAVIDSON (HCSO SUPPLIER SI-301227), FOR THE PURCHASE OF 10-ROAD KING HARLEY-DAVIDSON MOTORCYCLES TO INCLUDE PRODUCTS AND SERVICES IN AN AMOUNT NOT TO EXCEED BUDGETED FUNDS; AUTHORIZING THE CITY MANAGER TO EXPEND FUNDS FROM ACCOUNT No. 001.60005.500641; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Police Department for the City of Doral (the "City") seeks to purchase ten (10) Harley-Davidson motorcycles to include products and services via the Hillsborough County Sheriff's Office (HCSO Supplier SI-301227); and

**WHEREAS**, the City of Doral Police Department recommends the replacement of 10 Harley Davidson motorcycles. These motorcycles have accumulated significant mileage and show signs of extensive wear, making them due for replacement.; and

**WHEREAS**, section 2-322 of the City Code of Ordinances authorizes the City to purchase products and services via the contracts of other governmental entities, provided that such contracts have been achieved in a competitive manner similar to those established in the City Code; and

**WHEREAS**, staff recommends that the City Council authorize the City Manager to access the Hillsborough County Sheriff's Office (HCSO Supplier SI-301227) for the purchase of 10 Harley-Davidson motorcycles to include products and services from Alligator Alley Harley-Davidson in an amount not to exceed budgeted funds, which was competitively entered into in a matter similar to that set forth in Chapter 2, Article

V of the City Code; and

**NOW, THEREFORE BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The foregoing recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

**Section 2. Approval.** Pursuant to section 2-322, the purchase of 10 Harley-Davidson motorcycles to include products and services from Alligator Alley Harley-Davidson via the Hillsborough County Sheriff's Office (HCSO Supplier SI-301227) in an amount not to exceed budgeted funds is hereby approved. This purchase is funded from the Capital Outlay-Vehicles #001.60005.500641 or other most appropriate account(s) as approved in the budget.

**Section 3. Authorization.** The City Manager is hereby authorized to enter into an agreement and other contractual documents, subject to approval as to form and legal sufficiency by the City Attorney, as may be necessary to procure the motorcycles under the Hillsborough County Sheriff's Office contract, and to expend budgeted funds as necessary in order to fulfill the City's obligations under the contract.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.
