### **DEPARTMENT ASSIGNMENTS**

#### **State Attorney's Office (SAO) Human Trafficking Task Force**

The Doral Police Department (DPD) is proud to announce that two of our Criminal Investigations Bureau members were sworn in on April 10, 2025, as the newest members of the SAO Human Trafficking Task Force. Sergeant Patricia Vazquez and Detective Alejandro Martinez will represent the DPD with pride and professionalism.

### **SPECIAL DETAILS AND EVENTS**

#### **LIV Golf Tournament**

The 2025 LIV Golf Tournament was held at the Trump National Doral Golf Resort from April 4 to April 6, 2025. The DPD provided off duty police services to assist Trump National Doral and the LIV Golf Organization. The coordination of security details consisted of providing protection and escorts for marquee players, ensuring the safety of spectators, providing security at the children's nursery, and other interior security posts. Doral police officers were also assigned to traffic posts at specified intersections to ensure that traffic flowed smoothly around the venue.

#### **Autism Awareness Patches and Badges Campaign**

During the month of April, members of the DPD participated in an Autism Awareness and Acceptance Campaign and encouraged the recognition of neurodiversity. Throughout the month of April, Department personnel were authorized to replace the police patches on the sleeves of their uniforms with Autism Awareness patches and Autism Awareness badges were also worn by many in support.

#### **Autism Bike Ride 2025**

On April 12, 2025, the Miami-Dade Fire Rescue (MDFR) and Miami-Dade Sheriff's Office hosted their 6th Annual Autism Riding for the Cause Event to benefit Autism Awareness. The event consisted of a 40-mile and a 12.17-mile bike course. Members of the DPD and City of Doral came out in support and participated in the bike ride and event festivities.

### **Special Needs Registry Program Campaign**

The DPD's Special Needs Program is an excellent way for Doral residents who have loved ones with special needs to alert first responders that they may be interacting with, or about to interact with a person with special needs. The more information officers have when they respond to calls for service, the better they can meet our residents' needs. The City of Doral's Special Needs Registry is a voluntary service open to all residents with special needs who live in the City of Doral. The registry was created to help our police officers better assist persons with special needs in the event of an emergency by providing first responders with vital information regarding registrant's special needs. Each of the participating families have been provided with decals that can be placed at the front entrance of the registrant's residence as well as on the window of any vehicle in which they regularly travel. The presence of the Special Needs Registry decal allows law enforcement to know that someone in the residence or vehicle may have a special need and that they should respond accordingly.

### **D.A.R.E. Graduation**

On April 11, 2025, the fifth-grade class of Doral International Academy of Math and Science completed the Drug Abuse Resistance Education (D.A.R.E.) program with a graduation ceremony marking their achievement. Taught by DPD officers, this school-based drug use prevention program is a large part of the positive impact our officers make on the young members of our community.
