Major Project Updates

- IAS Accreditation Submitted
 - Submission to accreditation board was made July 25.
 - Board performs a cursory review and then schedules an on-site visit.
- EnerGov Upgrade Ongoing
 - Production update to EPL 2023.1 completed May 11, 2024. Ongoing issues with vendor, intermittent outages, need for next upgrade, etc.
