

RESOLUTION No. 26-

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY ANTUANET ALVAREZ TO HOST THE “DOWNTOWN DORAL WORLD CUP WATCH PARTY AT POCKET PARK” AT 5275 PASEO BOULEVARD DORAL, FL 33166, AND 5241 NW 87 AVENUE, FL 33178 FROM JUNE 11, 2026, THROUGH JULY 19, 2026, FROM 10:00 A.M. TO 10:00 P.M.; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS Antuanet Alvarez (the “Applicant”) seeks approval from the City of Doral to host the “Downtown Doral World Cup Watch Party at Pocket Park” special event at 5252 Paseo Boulevard Doral, Fl, 33166, and 5241 NW 87 Avenue Doral, Fl, 33178; and

WHEREAS the purpose of the event is to provide a safe, welcoming, and well-managed community gathering space that activates the heart of Downtown Doral during a globally celebrated sporting event, supports local restaurants and tenants, and reinforces the district as a premier destination for residents and visitors; and

WHEREAS staff recommends that the Mayor and City Council approve the proposed “Downtown Doral World Cup Watch Party at Pocket Park” special event permit with conditions to be held from Thursday, June 11, 2026, through Sunday, July 19, 2026, from 10:00 a.m. to 10:00 p.m.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

Section 2. Approval. The special event permit for the “Downtown Doral World Cup Watch Party at Pocket Park” is hereby approved subject to the following conditions:

1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.
2. The Applicant shall be required to have secure all required inspections and approvals prior to the event date.
3. Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number to meet the requirements established by the Building Department.
4. The Applicant is responsible for providing adequate security at the special event. The police department has provided an estimate for crowd control and traffic direction purposes.
5. Miami-Dade Fire Rescue may require the Applicant to provide and pay for fire watch personnel.
6. The Applicant shall provide the City of Doral an acceptable certificate of insurance naming the city as an additional insured thirty (30) days prior to the event date.
7. The applicant should provide adequate parking for the attendees.
8. The Applicant shall comply with the City’s noise ordinance.
9. All fees due must be paid no later than 14 days in advance of the event. Total fees due for Downtown Doral World Cup Watch Party at Pocket Park special event are \$1,015.00 for Planning and Zoning and Technology fees. Police Service Fees are \$11,774.21.

Section 3. Effective Date. This Resolution shall become effective immediately upon its adoption.

Section 4. Implementation. The City Manager and City Attorney are authorized to take any additional actions necessary to implement this Resolution, including making any modifications, executing any documents and addendums as necessary to effectuate this Resolution, provided that such actions remain consistent with the Council’s intent.
