ITEM TITLE:

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXTEND THE CURRENT AGREEMENT WITH FLORIDA RECREATIONAL SPORTS FOR SIX (6) MONTHS; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

DEPARTMENT RECOMMENDATION:

Approval

BRIEF HISTORY:

The Parks and Recreation Department respectfully requests approval from the Mayor and City Council to authorize the City Manager to execute an extension of the agreement with Florida Recreational Sports for the provision of providing Youth Baseball Competitive & Travel Programming for a period of six (6) months.

Florida Recreational Sports has been providing youth baseball development and programming at Doral Meadow Park since 2021; and averages over 250 each during the fall & spring seasons.

In 2021, Mayor and City Councilmembers approved the City Manager to enter into an agreement with to offer competitive and travel baseball to Florida Recreational Sports (Resolution No. 21-64).

There were renewal options executed in 2024 and again in 2025 with an expiration of July 19, 2026, with no remaining renewal options on their current agreement.

Florida Recreational Sports has a 90% satisfaction rate amongst survey participants responding.

The Parks and Recreation Department respectfully requests extending the current agreement for six (6) months.
