

**RESOLUTION No. 26-**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING A MUNICIPAL SPONSORSHIP TO HISPA (HISPANICS INSPIRING STUDENTS' PERFORMANCE AND ACHIEVEMENT) IN THE AMOUNT OF ONE THOUSAND DOLLARS AND 00/100 (\$1,000.00), PURSUANT TO SECTION 2-79 OF THE CITY'S CODE OF ORDINANCES; PROVIDING FOR AUTHORIZATION; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Section 2-79 of the Code of Ordinances for the City of Doral ("City") governs municipal sponsorships and provides that each councilmember is allotted \$5,000.00 per fiscal year (contingent upon annual city budget approval) to sponsor eligible applicants whose events, services, and programs support the City's vision, mission, and values as set forth in the City's adopted strategic plan and provide a community benefit; and

**WHEREAS**, the purpose of this section is to establish procedures for all municipal sponsorships, including the disbursement of discretionary funds approved by city councilmembers to sponsor programs, services, events, and charitable and civic organizations that serve a municipal purpose; and

**WHEREAS**, in a continued commitment to supporting non-profit organizations that embody our core values and significantly contribute to the well-being of our community, Councilwoman Nicole Reinoso proposes sponsorship for HISPA; and

**WHEREAS**, HISPA is a non-profit organization dedicated to expanding access to education and opportunity for underserved communities, with a primary focus on mentorship, by pairing students with trained volunteers and professionals who provide guidance, academic encouragement, leadership development, and exposure to

educational and career pathways through structured, in-school and community-based programming that supports students and their families; and

**WHEREAS**, HISPA operates in multiple regions, including South Florida, and its programs and initiatives support students and families by fostering educational attainment, civic engagement, and workforce readiness, aligning with the City of Doral's commitment to education, youth empowerment, and community advancement; and

**WHEREAS**, **WHEREAS**, in accordance with Section 2-79 of Municipal Sponsorships, Councilwoman Nicole Reinoso proposes a municipal sponsorship in the amount of one thousand dollars and 00/100 (\$1,000.00) to support HISPA's educational and mentorship-focused programs; and

**WHEREAS**, the City Council finds that the proposed municipal sponsorship complies with Section 2-79 of the City's Code of Ordinances and that the sponsorship serves a valid municipal purpose.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated herein.

**Section 2. Approval & Authorization.** The Mayor and City Council hereby approve the municipal sponsorship proposed by Councilwoman Nicole Reinoso to HISPA (Hispanics Inspiring Students' Performance and Achievement). The City Manager is hereby authorized to expend the budgeted funds.

**Section 3. Implementation.** The City Manager is hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

**Section 4. Effective Date.** This Resolution shall take effect immediately upon adoption.
