

**RESOLUTION No. 26-**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, WAIVING THE COMPETITIVE BID PROCESS PURSUANT TO SECTION 2-321 OF THE CITY'S CODE OF ORDINANCES; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH DORAL SOCCER CLUB FOR THE PROVISION OF YOUTH SOCCER PROGRAM MANAGEMENT AT MORGAN LEVY PARK RESPECTIVELY FOR A PERIOD OF THREE (3) YEARS WITH TWO (2) ONE (1) YEAR RENEWALS; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral ("City"), through its Parks and Recreation Department, is currently in an agreement with both Doral Soccer Club at Morgan Levy Park where they offer youth soccer programming to our community; and

**WHEREAS**, through feedback from participants and parents the Parks & Recreation Department determined there is a need to continue this program due to high demand for these services. Doral Soccer Club has always scored excellent results in their annual surveys. They have more than Four Hundred and Fifty (450) participants on a monthly basis, which more than 90% are residents of the City of Doral; and

**WHEREAS**, The City went out to bid for youth soccer services in 2017 (RFP #2017-30). Doral Soccer Club was awarded in Res. 18-66 during the April 11, 2018 council meeting; and

**WHEREAS**, After three (3) successful seasons with Doral Soccer Club, the City went back out to bid as their agreement was expiring. Once again, Doral Soccer Club was awarded in RFP #2021-4 and awarded by council in Res. 21-102 during the April 14, 2021 council meeting; and

**WHEREAS**, The agreement was signed on June 3, 2021, with a Notice to Proceed signed for June 4, 2021. The agreement was renewed in 2024 and 2025 with an expiration

date of June 4, 2026; and

**WHEREAS**, through feedback from participants and parents the Parks & Recreation Department determined there is a need to continue this program due to high demand for these services; and

**WHEREAS**, the City finds it in its best interests to continue the soccer programming provided by Doral Soccer Club at Morgan Levy Park for stability and consistency.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval & Authorization.** The City Council hereby waives the formal bid process pursuant to Section 2-321 of the City's Code Ordinance and authorizes the City Manager to negotiate and enter into an agreement with agreement with Doral Soccer Club for the provision of providing Youth Soccer Program Management. The revenue split will be paid by the provider to the City and deposited into GL account 001.9000.347404 (Recreation-Soccer), subject to the terms and conditions acceptable to the City Manager and City Attorney;

**Section 3. Implementation.** The City Manager and City Attorney are authorized to take any additional actions necessary to implement this Resolution, including making any modifications, executing any documents and addendums as necessary to effectuate this Resolution, provided that such actions remain consistent with the Council's intent.

**Section 4. Effective Date.** This resolution shall take effect immediately upon

adoption.
