

**RESOLUTION No. 25-**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY PSBP INDUSTRIAL LLC TO HOST THE “CUSTOMERS APPRECIATION LUNCH” AT LINKS PARKS LOCATED AT 8181 NW 14 STREET, DORAL ON WEDNESDAY, NOVEMBER 5, 2025, FROM 8:00 A.M. TO 4:00 P.M.; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS** PSBP Industrial LLC (“Applicant”) seeks approval from the City of Doral to host the “Customer Appreciation Lunch” special event at PSBP Industrial LLC, located at 8181 NW 14 Street, Doral, Florida, and

**WHEREAS** the purpose of this event is to recognize customers for their patronage, and

**WHEREAS** staff recommends that the Mayor and City Council approve the proposed “Customer Appreciation Lunch” special event permit to be held from Wednesday, November 5, 2025, from 8:00 a.m. to 4:00 p.m.

**NOW, THEREFORE, BE RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

**Section 2. Approval.** The special event permit for the “Customer Appreciation Lunch” is hereby approved subject to the following conditions:

1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.
2. The Applicant shall be required to secure all inspections and approvals prior to the event date.

3. Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number to meet the requirements established by the Building Department.
4. The Applicant is responsible for providing adequate security at the special event. The police department has provided an estimate for crowd control and traffic direction purposes.
5. Miami-Dade Fire Rescue may require the Applicant to provide and pay for fire watch personnel.
6. The Applicant shall comply with the comments made by the City of Doral Police Department and pay all applicable fees no later than 14 days in advance of the event.
7. The applicant should provide adequate parking for the attendees.
8. The Applicant shall comply with the City's noise ordinance.
9. All fees due must be paid within thirty days upon special event approval. All fees must be paid by October 10, 2025. Total fees due for Customer Appreciation Lunch special event are Two Thousand, Three Hundred Fifty Two Dollars and 97/100 (\$2,352.97) which represents One Thousand Nine Hundred Eighty Seven Dollars and 97/100 (\$1,987.97) for Police services and \$365.00 for Planning and Zoning and Technology fees.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon its adoption.
