

RESOLUTION No. 25-

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY DANIEL CHOCRON TO HOST THE “IRIE JUNGLE 2025” AT TRIPPING ANIMALS BREWING LOCATED AT 2685 NW 105 AVENUE, DORAL, FL 33172, ON SATURDAY, APRIL 19, 2025, FROM 12:00 P.M. TO 6:00 P.M.; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS Daniel Chocron (the “Applicant”) seeks approval from the City of Doral to host the “Irie Jungle 2025” special event at Tripping Animals Brewing; and

WHEREAS the purpose of this event is to celebrate the 7th year store anniversary and release a new product; and

WHEREAS staff recommends that the Mayor and City Council approve the proposed “Irie Jungle 2025” special event permit to be held Saturday, April 19, 2025, from 12:00 p.m. to 6:00 p.m.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

Section 2. Approval. The special event permit for the “Irie jungle 2025” is hereby approved subject to the following conditions:

1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.
2. The Applicant shall be required to have all inspections and approvals prior to the event date.

3. Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number as to meet the requirements established by the Building Department.
4. The Applicant is responsible for providing adequate security at the special event. The police department may require the Applicant to provide and pay for security personnel for crowd control and traffic direction purposes. The county fire rescue department may require the Applicant to provide and pay for fire watch personnel.
5. The Applicant shall comply with the comments made by the City of Doral Police Department.
6. The Applicant shall provide to the City of Doral an acceptable certificate of insurance naming the city as an additional insured four weeks prior to the event date.
7. If applicable, the Applicant shall secure a maintenance of traffic (MOT) permit from the City of Doral Public Works Department and/or Miami-Dade County Department of Transportation and Public Works prior to event start date.
8. The Applicant shall provide overflow parking arrangements.
9. All fees due must be paid within thirty (30) days upon special event approval. Total fees due for Irie Jungle 2025 special event are \$2,647.82 which represents \$2,282.82 for Police services and \$365.00 for Planning and Zoning Technology

Section 3. Effective Date. This Resolution shall become effective immediately upon its adoption.
