A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY NORBERTO SPANGARO TO HOST THE "TERCER CAMPEONATO DEL ASADO ARGENTINO" EVENT AT CENTRAL PARK LOCATED AT 3005 NW 97 AVENUE ON SATURDAY, NOVEMBER 22, 2025, FROM 12:00 P.M. TO 10:00 P.M.; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS Norberto Spangaro (the "Applicant") seeks approval from the City of Doral to host the "Tercer Campeonato del Asado Argentino" special event at Doral Central Park located at 3005 NW 97 Avenue, Doral, Florida, 33166, and

WHEREAS the purpose of this event is to promote cultural exchange in the context of an outdoor culinary championship event; and

WHEREAS staff recommends that the Mayor and City Council approve the proposed "Tercer Campeonato del Asado Argentino" special event permit to be held from Saturday, November 22, 2025, from 12:00 p.m. to 10:00 p.m.

NOW, THEREFORE, BE RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

<u>Section 2.</u> Approval. The special event permit for the "Tercer Campeonato del Asado Argentino" is hereby approved subject to the following conditions:

- 1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.
- 2. The Applicant shall be required to secure all inspections and approvals prior to the event date.

- Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number to meet the requirements established by the Building Department.
- 4. The Applicant is responsible for providing adequate security at the special event. The police department has provided an estimate for crowd control and traffic direction purposes.
- 5. Miami-Dade Fire Rescue may require the Applicant to provide and pay for fire watch personnel.
- 6. The Applicant shall comply with the comments made by the City of Doral Police Department and pay all applicable fees no later than 14 days in advance of the event.
- 7. The applicant should provide adequate parking for the attendees.
- 8. The Applicant shall comply with the City's noise ordinance.
- 9. All fees due must be paid within thirty days upon special event approval. All fees must be paid by September 13, 2025. Total fees due for Tercer Campeonato del Asado Argentino special event are \$38,247.84 which represents \$19,784.44 for Police services and \$365.00 for Planning and Zoning and Technology fees and \$18,098.40 for Parks rentals and refundable security deposit.

<u>Section 3.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.
