A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY AMANDA RODRIGUEZ ON BEHALF OF THE UNIVERSITY OF MIAMI TO HOST THE "UNIVERSITY OF MIAMI HEALTH IN MOTION" EVENT AT DORAL MAIN STREET IN THE AREA FROM PASEO BLVD TO NW 84 AVENUE, DORAL, FL 33166, ON SATURDAY, APRIL 26, 2025, FROM 9:00 A.M. TO 1:00 P.M.; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS Amanda Rodriguez (the "Applicant") seeks approval from the City of

Doral to host the "University of Miami Health in Motion" special event at Doral Main Street

from Paseo Blvd. to NW 84 Avenue area; and

WHEREAS the purpose of this event is to bring to the City of Doral community

free accessible health resources and promote the UHealth Doral new facility ; and

WHEREAS staff recommends that the Mayor and City Council approve the

proposed "University of Miami Health in Motion" special event permit to be held Saturday,

April 26, 2025, from 9:00 a.m. to 1:00 p.m.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY

COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

Section 2. <u>Approval.</u> The special event permit for the "University of Miami-

Health in Motion" is hereby approved subject to the following conditions:

1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.

- 2. The Applicant shall be required to have all inspections and approvals prior to the event date.
- 3. Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number as to meet the requirements established by the Building Department.
- 4. The Applicant is responsible for providing adequate security at the special event. The police department may require the Applicant to provide and pay for security personnel for crowd control and traffic direction purposes. The county fire rescue department may require the Applicant to provide and pay for fire watch personnel.
- 5. The Applicant shall comply with the comments made by the City of Doral Police Department.
- 6. The Applicant shall provide to the City of Doral an acceptable certificate of insurance naming the city as an additional insured four weeks prior to the event date.
- 7. If applicable, the Applicant shall secure a maintenance of traffic (MOT) permit from the City of Doral Public Works Department and/or Miami-Dade County Department of Transportation and Public Works prior to event start date.
- 8. The Applicant shall provide overflow parking arrangements.
- All fees due must be paid within thirty (30) days upon special event approval. Total fees due for University of Miami Health in Motion special event are \$969.00 which represents \$604.00 for Police services and \$365.00 for Planning and Zoning Technology.

Section 3. Effective Date. This Resolution shall become effective immediately

upon its adoption.
