

RESOLUTION No. 25-

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE BILL OF SALE WITH THE TOWN OF MEDLEY FOR THE SALE OF SIX HARRIS HANDHELD RADIOS; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral ("Doral") currently owns the following six Harris Handheld radios:

WHEREAS, the Doral Police Department recently acquired Motorola Radios for the entire police department through a grant, which has resulted in a surplus of radios that we are eager to share; and

WHEREAS, the Town of Medley has voiced its interest in acquiring the radios for use by its police department; and

WHEREAS, the City Council finds that it is in the best interest of Doral to donate the aforementioned radios, which are no longer of use or value to the Doral Police Department, to Medley.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. The City Council of the City of Doral hereby approves the Bill of Sale between the City of Doral and the Town of Medley for the sale of six Harris Handheld radios, which the Bill of Sale is attached hereto and incorporated herein as Exhibit "A".

Section 3. Implementation. The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.
