ITEM TITLE:

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE AWARD OF REQUEST FOR PROPOSALS RFP #2025-23, "FOURTH OF JULY FIREWORKS DISPLAY," TO THE TOP-RANKED PROVIDER; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH LIGHT FX PROS LLC FOR THE PROVISION OF THE CITY'S FOURTH OF JULY FIREWORKS DISPLAYS FOR THE INDEPENDENCE DAY CELEBRATION EVENT FOR A PERIOD OF THREE (3) YEARS WITH ONE (1) TWO (2) YEAR RENEWAL TERM, FOR A TOTAL OF FIVE (5) YEARS, IN AN AMOUNT NOT TO EXCEED APPROVED BUDGETED FUNDS PER FISCAL YEAR; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

BRIEF HISTORY:

The City of Doral Parks and Recreation Department holds the City's annual Fourth of July Celebration event at Doral Central Park which includes a 25-minute synchronized musical fireworks show. The fireworks display is located on a barge inside the lake within the park which provides optimal viewing for event attendees and minimal closures to the park for the fall out zone.

The City of Doral ("City"), through its Parks and Recreation and Procurement and Asset Management Departments, prepared Request for Proposals (RFP) No. 2025-23 to solicit qualified and experienced vendors to provide a synchronized musical fireworks display for the City's Fourth of July celebration. Services include all permitting and coordinating with relevant departments such as Fire rescue, Federal Aviation Authority (FAA) and others as needed.

The RFP was issued on October 9, 2025, and posted on OpenGov and distributed to a network of vendors. A non-mandatory pre-bid meeting was held on October 23, 2025. On November 6, 2025 the City received one (1) proposal from Light FX Pros LLC in an amount of \$65,000.00 per year. The proposal was evaluated and deemed responsive and responsible.

The City Manager has reviewed and concurs with the award recommendation.

The contract terms provide for an **initial three-year (3) period**, with **one (1) additional two-year (2) renewal option** at the City's discretion.
