

RESOLUTION No. 26-

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY DANIEL CHOCRON ON BEHALF OF TRIPPING ANIMALS BREWING, LLC, TO HOST THE “IRIE JUNGLE 2026” SPECIAL EVENT AT 2685 NW 105 AVE, DORAL, FL ON SATURDAY, APRIL 18, 2026, FROM 1:00 P.M. TO 5:00 P.M.; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Daniel Chocron (the “Applicant”) on behalf of Tripping Animals Brewing, LLC (“Event Organizer”) seeks approval from the City of Doral (“City”) to host the “Irie Jungle 2026” special event at 2685 NW 105 Avenue, Doral, FL 33172, as detailed in Exhibit “A”; and

WHEREAS, the purpose of this event is to celebrate the release of a new product for the Event Organizer, while promoting the brewery; and

WHEREAS, staff recommends that the Mayor and City Council approve the proposed “Irie Jungle 2026” special event permit to be held Saturday, April 18, 2026, from 1:00 p.m. to 5:00 p.m., subject to the conditions set forth herein.

NOW, THEREFORE, BE RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

Section 2. Approval. The special event permit for the “Irie Jungle 2026” is hereby approved subject to the following conditions:

1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the City.

2. The Applicant shall be required to secure all inspections and approvals prior to the event date.
3. Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number as to meet the requirements established by the City's Building Department.
4. The Applicant is responsible for providing adequate security at the special event. The City's Police Department has provided an estimate for crowd control and traffic direction purposes.
5. Miami-Dade Fire Rescue may require the Applicant to provide and pay for fire watch personnel.
6. The Applicant shall comply with the comments made by the City of Doral Police Department and pay all applicable fees no later than 14 days in advance of the event.
7. The Applicant shall provide to the City of Doral an acceptable certificate of insurance naming the City as an additional insured four weeks prior to the event date.
8. The Applicant shall provide adequate parking for the attendees and overflow parking arrangements.
9. The Applicant shall comply with the City's noise ordinance.
10. All fees due must be paid no later than 14 days in advance of the event. All fees must be paid by April 4, 2026. Total fees due for Irie Jungle 2026 special event are Two Thousand Nine Hundred Fourteen Dollars and 29/100 (\$2,914.29) which represents Two Thousand Five Hundred Forty Nine Dollars and 29/100 (\$2,549.29) for Police services, and Three Hundred Sixty Five Dollars (\$365.00) for Planning and Zoning and Technology fees.

Section 3. Effective Date. This Resolution shall become effective immediately upon its adoption.

Section 4. Implementation. The City Manager and City Attorney are authorized to take any additional actions necessary to implement this Resolution, including making any modifications, executing any documents and addendums as necessary to effectuate

this Resolution, provided that such actions remain consistent with the Council's intent.
