A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY EDUARDO OROZCO TO HOST THE "MIAMI INLINE MARATHON 2025" EVENT IN THE PERIMETER OF NW 97, 102 AND 107 AVENUES, FROM NW 74 AND 102 STREETS, TO NW 62 AND 66 STREETS AND 87 AVENUE ON SUNDAY, OCTOBER 12, 2025, FROM 6:00 A.M. TO 10:00 A.M.; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS Eduardo Orozco (the "Applicant") seeks approval from the City of Doral to host the "Miami Inline Marathon" special event along NW 97, 102 and 107 avenues, from NW 74 through 102 streets, including 62 and 66 streets and NW 87 avenue Doral, Florida, 33166, and

WHEREAS the purpose of this event is to encourage the participation of Doral residents and local businesses in a dynamic healthy and active environment exchange event; and

WHEREAS staff recommends that the Mayor and City Council approve the proposed "Miami Inline Marathon" special event permit to be held from Sunday, October 12, 2025, from 6:00 a.m. to 10:00 p.m.

NOW, THEREFORE, BE RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

<u>Section 2.</u> Approval. The special event permit for "Miami Inline Marathon" is hereby approved subject to the following conditions:

- 1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.
- 2. The Applicant shall be required to secure all inspections and approvals prior to the event date.
- Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number to meet the requirements established by the Building Department.
- 4. The Applicant is responsible for providing adequate security at the special event. The police department has provided an estimate for crowd control and traffic direction purposes.
- 5. Miami-Dade Fire Rescue may require the Applicant to provide and pay for fire watch personnel.
- 6. The Applicant shall comply with the comments made by the City of Doral Police Department and pay all applicable fees no later than 14 days in advance of the event.
- 7. The applicant should provide adequate parking for the attendees.
- 8. The Applicant shall comply with the City's noise ordinance.
- 9. All fees due must be paid within thirty days upon special event approval. All fees must be paid by September 13, 2025. Total fees due for Miami Inline Marathon special event are Eight Thousand, One Hundred Thirty Seven Dollars and 28/100 (\$8,137.28), which represents Seven Thousand, Seven Hundred Seventy Seven Dollars and 28/100 (\$7,777.28) for Police services and \$365.00 for Planning and Zoning and Technology fees.

<u>Section 3.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.
