

**RESOLUTION No. 25-**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING A BUDGET TRANSFER OF \$380,900.00 FROM ACCOUNT No. 001.50005.500492 TO ACCOUNT No. 001.50005.500450; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral (the “City”) has had an increase in insurance costs;  
and

**WHEREAS**, the General Government budget has additional money within the Contingent Reserve account that is available for re-allocation; and

**WHEREAS**, the city wishes to transfer Three Hundred Eighty Thousand, Nine Hundred Dollars and 00/100 (\$380,900.00) from the General Government Contingent Reserve account to meet the insurance cost increase; and

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Transfer Authorized.** The transfer of Three Hundred Eighty Thousand, Nine Hundred Dollars and 00/100 (\$380,900.00) from the General Fund Contingent Reserve account, 001.50005.500492, to the General Fund Insurance account, 001.50005.500450 in order to provide funds for the increase in insurance cost is hereby approved.

**Section 3. Implementation.** The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

**Section 4. Effective Date.** This resolution shall take effect immediately upon adoption.
